RELATING TO PUBLIC-PRIVATE PARTNERSHIPS FOR THE DELIVERY OF HEALTH CARE SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

4	SECTION 2. Section 323F-52, Hawaii Revised Statutes, is

9	(a) Notwithstanding any other law to the contrary, including					
10	but not limited to section $27-1[\tau]$; section $76-16(b)$ and other					
11	sections of chapter 76[$_{7}$]; chapters 78, 89, 89A, 89C, and					
12	171 $[\tau]_{\underline{i}}$ part V of chapter 323D $[\tau]_{\underline{i}}$ and sections 323F-11 and					
13	323F-31, the governor, with the assistance of the chief					
14	executive officer of the corporation, and the regional chief					
15	executive officer of the Maui regional system, or their					
16	designees, shall negotiate with a private entity to transfer the

- (c) On and after the transfer completion date for the transfer of one or more facilities of the Maui regional system to a private entity or its nonprofit management entity pursuant to this part, the State, the corporation, and the Maui regional system and its board shall cease to have any responsibility for or control over the management and operation of the facility or facilities transferred by the agreement pursuant to this part.

- 1 (d) Beginning January 1, 2024, before entering into any
- 2 new agreement or modifying or terminating any existing agreement
- 3 entered into pursuant to this part, the chief executive officer
- 4 of the corporation or the chief executive officer's designee
- 5 shall provide the governor with written comments, including any
- 6 representations made by the private entity to the corporation or
- 7 Maui regional system related to the management and operation of
- 8 and provision of health care services at the facility or
- 9 facilities transferred or being transferred by the agreement
- 10 pursuant to this part."
- 11 SECTION 3. This Act does not affect rights and duties that
- 12 matured, penalties that were incurred, and proceedings that were
- 13 begun before its effective date.
- 14 SECTION 4. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 5. This Act shall take effect on December 31,

Hawaii Health Systems Corporation; Maui Regional System Facilities; Public-Private Partnerships; Private Entity

Description:

Beginning January 1, 2024, require the Chief Executive Officer of the Hawaii Health Systems Corporation or the Chief Executive Officer's designee to provide written comments to the Governor before the State enters into any new agreement with a private entity or modifies or terminates any existing agreement to transfer the right and responsibility to manage, operate and otherwise provide health care services at one or more facilities of the Maui Regional System. Expands the definition of "private entity" to include business organizations that are authorized to transact business in the State, including nonprofit management entities that have a certificate of need or license to operate one or more community hospitals or hospitals serving a rural population licensed under the laws of any state. Effective 12/31/2050. (SD1)
