### A BILL FOR AN ACT

RELATING TO SAFE ROUTES TO SCHOOL.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that transforming 2 Hawaii's surface transportation systems and infrastructure to 3 prioritize walking, rolling, bicycling, and public transit is at the nexus of the State's commitments to public health, public 4 5 safety, economic vitality, and environmental sustainability. 6 The most important component of this transformation is ensuring 7 that every child in Hawaii enjoys the infrastructure, social 8 support, confidence, and skills to walk, roll, bike, or bus to 9 school.

10 The legislature further finds that ensuring safe routes to 11 school for every keiki will not only protect our most vulnerable 12 road users, but also serve as a long-term investment in the 13 future of transportation in the State. However, the legislature 14 recognizes that decades of automobile-centric planning and 15 development have created formidable barriers to this 16 transformation. These barriers include a lack of complete, 17 safe, and comfortable bike and pedestrian networks; burdensome

3	to school	plan that creates performance measures, goals,
4	strategie	s, and accountability; and a lack of coordination of

8	(1)	Establish the safe routes to school advisory committee
9		to develop a comprehensive statewide safe routes to
10		school plan to advise the State on strategies to
11		ensure that each child in the State is able to safely
12		bike, walk, roll, or bus to that child's respective
13		school; and
14	(2)	Appropriate moneys for the department of
15		transportation to hire additional staffing, including
16		one full-time equivalent (1.0 FTE) safe routes to
17		school program coordinator, and procure facilities and
18		equipment necessary to support the safe routes to
19		school advisory committee.

5		amended by the Every Student Succeeds Act.
6	(c)	The safe routes to school advisory committee shall:
7	(1)	Make the comprehensive statewide safe routes to school
8		plan developed pursuant to subsection (b) available to
9		the public no later than November 1, 2026; and
10	(2)	Submit a copy of the comprehensive statewide safe
11		routes to school plan developed pursuant to subsection
12		(b), including any proposed legislation, to the
13		legislature no later than twenty days prior to the
14		convening of the regular session of 2027.
15	(d)	The safe routes to school advisory committee shall
16	<u>consist o</u>	f the following members:
17	(1)	The safe routes to school program coordinator;
18	(2)	A representative of the physical activity and
19		nutrition branch of the department of health; and
20	(3)	A representative of the department of education.

10	years,	members shall serve for two years, and the
11	remaining	members shall serve for one year.
12	(g)	The safe routes to school advisory committee shall:
13	(1)	Meet no less than monthly to review the State's
14		progress in implementing the State's safe routes to
15		school program; and
16	(2)	Make recommendations to the department of
17		transportation no less than biannually;
18	provided	that the safe routes to school advisory committee may
19	meet and	make recommendations to the department of
20	transport	ation at additional times as a majority of the members

1	(h) The members of the safe routes to school advisory
2	committee shall serve without compensation but shall be
3	reimbursed for expenses, including travel expenses, necessary
4	for the performance of their duties."
5	SECTION 3. There is appropriated out of the general
6	revenues of the State of Hawaii the sum of \$ or so much
7	thereof as may be necessary for fiscal year 2023-2024 and the
8	same sum or so much thereof as may be necessary for fiscal year
9	2024-2025 for the department of transportation to hire
10	additional staffing, including one full-time equivalent (1.0
11	FTE) safe routes to school program coordinator position, and
12	procure any facilities and equipment necessary to support the
13	safe routes to school advisory committee.
14	The sums appropriated shall be expended by the department
15	of transportation for the purposes of this Act.
16	SECTION 4. New statutory material is underscored.
17	SECTION 5. This Act shall take effect on July 1, 2023.
