### A BILL FOR AN ACT

RELATING TO INSTRUCTIONAL MATERIALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that books and other
- 2 instructional materials are needed in alternate accessible
- 3 formats for use by elementary and secondary school students who
- 4 are unable to use traditional formats as their primary learning
- 5 medium. Enacted in 2004, the Individuals with Disabilities
- 6 Education Improvement Act established a National Instructional
- 7 Materials Accessibility Standard and a National Instructional
- 8 Materials Access Center that receives electronic files from
- 9 publishers and provides the files to schools in a uniform
- 10 national format.
- 11 The legislature further finds that existing state law
- 12 pertaining to instructional materials directs publishers to meet
- 13 requirements that are now obsolete due to advancements in
- 14 technology and are inconsistent with the Individuals with
- 15 Disabilities Education Act to provide eligible students with
- 16 appropriate, accessible instructional materials crucial to
- 17 student progress and success. Therefore, revisions to current



- 1 practices are needed to conform the State to the Individuals
- 2 with Disabilities Education Act, including the expansion of
- 3 instructional materials in accessible formats and advancement of
- 4 current technology available for eligible students.
- 5 Accordingly, the purpose of this Act is to:
- 6 (1) Provide for the timely availability of appropriate,
- 7 accessible instructional materials and technology for
- 8 eligible students; and
- 9 (2) Provide for the distribution of accessible materials
- 10 to eligible students in accordance with the
- 11 Individuals with Disabilities Education Act and the
- 12 Copyright Act of 1976.
- 13 SECTION 2. Section 302A-442.5, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "\$302A-442.5 Instructional materials; [exceptional
- 16 children.] accessible format; eligible students. (a) Whenever
- 17 used in this section, unless a different meaning clearly appears
- 18 from the context:
- 19 "Accessible format" has the same meaning as in the
- 20 Copyright Act, 17 U.S.C. section 121(d)(1), as amended.

1 "Assistive technology device" has the same meaning as in 2 the Individuals with Disabilities Education Act, 20 U.S.C. section 1401(1)(A), as amended. 3 "Assistive technology service" has the same meaning as in 4 the Individuals with Disabilities Education Act, 20 U.S.C. 5 6 section 1401(2)(A) through (F), as amended. 7 "Braille" means the system of reading and writing through 8 touch commonly known as standard English braille. 9 "Eliqible student" means a student approved as an "eligible 10 person" as defined in the Copyright Act, 17 U.S.C. section 11 121(d)(3), as amended, attending an elementary or secondary 12 school, including: 13 (1) A public school; 14 (2) A private school; (3) A public charter school as defined in section 302D-1; 15 16 or(4) An approved alternative education program under 17 18 section 302A-1132(a)(5). "National Instructional Materials Access Center" means the 19 center established pursuant to the Individuals with Disabilities 20 21 Education Act, 20 U.S.C. section 1474(e), as amended.

1	"National Instructional Materials Accessibility Standard"
2	has the same meaning as in the Individuals with Disabilities
3	Education Act, 20 U.S.C. section 1474(e)(3)(B), as amended.
4	"Print instructional materials" means printed textbooks and
5	related printed core materials that are written and published
6	primarily for use in elementary and secondary school instruction
7	and are required by the department for use by students in the
8	classroom, including:
9	(1) Digital instructional materials obtained in an
10	appropriate accessible format for an eligible student;
11	<u>or</u>
12	(2) Materials that can be provided by the National
13	Instructional Materials Access Center in valid
14	National Instructional Materials Accessibility format.
15	"Technology mediated instruction" means learning that is
16	aided or entirely accomplished through the use of computer-based
17	technology.
18	(b) In accordance with the Individuals with Disabilities
19	Education Act, 20 U.S.C. section 1412(a)(23), the department
20	shall adopt the National Instructional Materials Accessibility
21	Standard for the purposes of providing instructional materials

1	to eligib	le students in a timely manner, and the department
2	shall coo	rdinate with the National Instructional Materials
3	Access Ce	nter to obtain appropriate instructional materials.
4	(c)	The department, as part of any print instructional
5	materials	adoption process, procurement contract, or other
6	practice	or instrument used for the purchase of print
7	instructi	onal materials, including digital materials, shall:
8	(1)	Obtain instructional materials from the publisher or
9		other source that are formatted in, or can be rendered
10		in, an appropriate accessible format for the eligible
11		student using the material; or
12	(2)	Enter into a written contract with the publisher of
13		the print instructional materials to require the
14		publisher to prepare and, on or before the delivery of
15		the print instructional materials, provide to the
16		National Instructional Materials Access Center
17		electronic files containing the contents of the print
18		instructional materials using the National
19		Instructional Materials Accessibility Standard if
20		instructional materials are not formatted in, or can
21		be rendered in, appropriate accessible format.

1	(d) In carrying out this section, the department shall
2	obtain instructional materials in accessible formats for
3	eligible students attending any public school and, to the
4	maximum extent allowed, assist any private school or public
5	charter school, or for any eligible student enrolled in an
6	approved alternative education program pursuant to section
7	302A-1132(a)(5), to obtain instructional materials in accessible
8	formats when the department receives a request from the school
9	or program; provided that the department shall not be liable for
10	the expense of any materials obtained other than the expense for
11	materials obtained for students attending public schools.
12	(e) Each eligible student shall receive instructional
13	materials in an accessible format most appropriate to the
14	content of the material and the student's needs. The material,
15	including any assistive technology device and assistive
16	technology service to be provided in advance and needed for the
17	student to use the material, shall be provided to the student at
18	the same time the print instructional materials are provided to
19	all other students.
20	(f) Technology shall be provided to each eligible student
21	receiving technology mediated instruction, including any

2		in braille may be used by the student in addition to
3		other accessible formats available if the student is
4		blind and receiving instruction in braille or the use
5		of braille;
6	(4)	List any assistive technology device and assistive
7		technology service needed for the eligible student to
8		use instructional materials and technology mediated
9		instruction in accessible formats, including the
10		timely and appropriate instruction to enable the
11		eligible student to use the technology to access age-
12		appropriate content independently;
13	(5)	Ensure that any assistive technology device and
14		assistive technology service used for instructional
15		materials in accessible formats is available for use
16		by the eligible student in school, at home, and in
17		other settings to the same extent that print
18		instructional materials are available to other
19		students; and
20	(6)	Identify and provide technology to be used by an
21		eligible student when receiving technology mediated

1	instruction, including any assistive technology device
2	and assistive technology service needed for the
3	technology to be accessible to and usable by the
4	eligible student.
5	[(b) All publishers of textbooks and instructional
6	materials sold to the State or any public school shall furnish
7	computer diskettes for literary subjects in the American
8	Standard Code for Information Interchange from which braille
9	versions can be produced. Publishers shall also furnish
10	computer diskettes in American Standard Code for Information
11	Interchange for nonliterary subjects including natural sciences,
12	computer science, mathematics, and music when braille specialty
13	code translation-software is available.
14	(e) (h) This section shall not apply to publishers of
15	textbooks and instructional materials written in the Hawaiian
16	language."
17	SECTION 3. Statutory material to be repealed is bracketed
18	and stricken. New statutory material is underscored.
19	SECTION 4. This Act shall take effect upon its approval.

### Report Title:

Instructional Materials; Assistive Technology; Eligible Students; Technology Mediated Instruction; National Instructional Materials Accessibility Standard

#### Description:

Adopts the National Instructional Materials Accessibility Standard for use by the Department of Education in preparation of instructional materials for eligible students. Defines "eligible student" in accordance with the Individuals with Disabilities Education Act and the Copyright Act. Requires the Department of Education to obtain instructional materials in accessible formats whenever available from the publisher or the National Instructional Materials Access Center when materials are not available from the publisher in the appropriate, accessible format needed by an eligible student. Requires instructional materials to be sufficient for grade level progress by eligible students. Requires the Department of Education to provide assistive technology devices and services for eligible students. Repeals requirements for publishers to provide computer diskettes conforming to American Standard Code for Information Interchange.
