# A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that hemp is among the SECTION 1. 2 fastest growing plants on earth and can be refined into a 3 variety of useful items such as paper, rope, textiles, clothing, 4 biodegradable plastics, paint, building insulation, biofuel, and 5 animal feed. Hemp-derived products are so wide-ranging that the creation of a decorticator processing facility and its 6 7 consequent production and sales of hemp-derived materials have 8 the potential to boost economic growth and create jobs in the 9 State.

10 The legislature further finds that there are potentially 11 numerous acreages designated for hemp production on Maui, and 12 that the lack of access to a decorticator facility hinders the 13 ability of growers and producers to engage in large scale 14 processing of hemp plants. Thus, a decorticator on Maui, 15 established by the department of agriculture, can provide for 16 meaningful growth of the hemp industry and related jobs in the 17 State.

1 The legislature additionally finds that the unusable parts 2 of processed hemp can be used to support organic composting in 3 the State. A decorticator can also be used by the Maui invasive 4 species committee and the department of land and natural 5 resources to properly process and dispose of invasive plant 6 species to disrupt a potential route of contamination back into 7 the land while also freeing up landfill space. 8 Accordingly, the purpose of this Act is to appropriate 9 funds to the department of agriculture to identify land for a 10 centrally accessible decorticator facility on Maui and to plan 11 such a facility for use by all eligible and interested parties 12 in these areas. 13 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 14 or so much thereof as may be necessary for fiscal year 2023-2024 and 15 16 the same sum or so much thereof as may be necessary for fiscal 17 year 2024-2025 for department of agriculture to identify a 18 centrally accessible area of Maui, and plan a hemp decorticator 19 facility for private and public use to process hemp and related 20 plants into exportable products.
