### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 52D-3.5, Hawaii Revised Statutes, is
2	amended by	y amending subsection (b) to read as follows:

4	(1)	Summarize the facts and the nature of the misconduct
5		for each incident;
6	(2)	Specify the disciplinary action imposed for each
7		incident;
8	(3)	Identify any other incident in the annual report
9		committed by the same police officer;
10	(4)	State whether the highest nonjudicial grievance
11		adjustment procedure timely invoked by the police
12		officer or the police officer's representative has
13		concluded:
14		(A) If the highest nonjudicial grievance adjustment
15		procedure has concluded, the report shall state:
16		(i) Whether the incident concerns conduct
17		punishable as a crime, and if so, describe

2		fact and conclusions of law concerning the

4		(ii) Whether the county police department
5		notified the respective county prosecuting

9		state the current stage of the nonjudicial
10		grievance adjustment procedure as of the end of
11		the reporting period; and
12	(5)	Disclose the identity of the police officer upon the
13		police officer's suspension or discharge[-] after the
14		following has occurred:
15		(A) The highest nonjudicial grievance adjustment
16		procedure timely invoked by the police officer or
17		the police officer's representative has
18		concluded;
19		(B) A written decision sustaining the suspension or
20		discharge has been issued after the highest
