#### A BILL FOR AN ACT

RELATING TO GENERAL EXCISE TAX.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii has the 2 highest cost of living in the nation. The general excise tax is 3 levied on nearly every economic activity, which, due to the 4 highly regressive structure of the tax, disproportionately 5 affects low-income and middle-class families. Although 6 businesses are required to pay general excise taxes out of their 7 gross receipts, those taxes are passed on to customers in the 8 form of higher prices. Because the general excise tax affects 9 almost all areas of economic activity, it can make it difficult 10 for average families to afford basic life expenses, such as 11 medical services, food, and housing.

12 The purpose of this Act is to exempt certain medical13 services, food, and rent from the general excise tax.

SECTION 2. Chapter 237, Hawaii Revised Statutes, is amended by adding three new sections to be appropriately designated and to read as follows:

2	be exempted from, and excluded from the measure of, the taxes
3	imposed by this chapter, all of the gross proceeds arising from
4	the sale of medical services.
5	(b) As used in this section, "medical services" includes
6	those services provided within hospitals, medical clinics, and
7	private medical practices that are performed by a person
8	licensed under chapter 436E, 442, 447, 448, 448B, 451A, 451J,
9	<u>451K, 452, 453, 453D, 455, 457, 457A, 457G, 458, 459, 461, 461J,</u>
10	<u>463E, 465, 465D, 466D, 466J, or 468E.</u>
11	§237- Exemption for sales of food. There shall be
12	exempted from, and excluded from the measure of, the taxes
13	imposed by this chapter, all gross proceeds or income arising
14	from the sale of Supplemental Nutrition Assistance Program-
15	eligible items; provided that soft drinks shall not be exempted
16	by this section.
17	§237 Exemption for rental payments. There shall be
18	exempted from, and excluded from the measure of, the taxes
19	imposed by this chapter, all gross proceeds arising from the
20	rental of residential real property."
