## A BILL FOR AN ACT

RELATING TO NOISE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to regulate the
- 2 excessively loud operation of a motor vehicle's sound
- 3 amplification system.
- 4 SECTION 2. Chapter 291, Hawaii Revised Statutes, is
- 5 amended by adding a new section to part II to be appropriately
- 6 designated and to read as follows:
- 7 "§291- Operation of radios, sound amplification systems,
- 8 or other mechanical or electronic sound-making devices in
- 9 vehicles. (a) No person operating or occupying a motor vehicle
- 10 shall operate or amplify, or permit to be operated or amplified,
- 11 the sound produced by a radio, sound amplification system, or
- 12 other mechanical or electronic sound-making device, which sound
- 13 emanates from the motor vehicle, so that the sound is audible to
- 14 the human ear at a distance of thirty feet or more from the
- 15 motor vehicle if the vehicle is located:
- 16 (1) On any public roadway, street, or highway; or
- 17 (2) In any residential zone or district;



- 1 provided that the radio, sound amplification system, or other
- 2 mechanical or electronic sound-making device is not being
- 3 operated to request assistance or warn of a hazardous situation.
- 4 (b) Any person who violates subsection (a) shall be fined
- 5 not less than \$25 but not more than \$250 for each separate
- 6 offense; provided that, if it is the person's intent to cause
- 7 serious inconvenience or substantial harm by operating the
- 8 radio, sound amplification system, or other mechanical or
- 9 electronic sound-making device at an excessive level or, if
- 10 after receiving a warning from a police officer to reduce the
- 11 noise level to within what is permissible under subsection (a),
- 12 and the person fails to do so, the person shall be guilty of a
- 13 petty misdemeanor. Each day of violation shall constitute a
- 14 separate offense.
- 15 (c) This section shall not apply to authorized emergency
- 16 vehicles or vehicles operated by gas, electric, communications,
- 17 or water utilities. This section shall not apply to the sound
- 18 systems of vehicles used for advertising, or in parades,
- 19 political or other special events; provided that the use of
- 20 sound systems in or on those vehicles is not prohibited by any
- 21 applicable county ordinance or resolution."

- 1 SECTION 3. This Act shall not preclude counties from
- 2 enacting their own ordinances; provided that state law shall
- 3 preempt county ordinances unless those ordinances' penalty
- 4 provisions as a whole are greater than those contained in this
- 5 Act.
- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect upon its approval.
