RELATING TO HOMELAND SECURITY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in order to succeed 2 in the legislated responsibilities of the State regarding 3 protection of critical infrastructure under chapter 128A, Hawaii 4 Revised Statutes, it is necessary to establish protections for 5 critical infrastructure information. 6 The purpose of this Act is to establish and specify 7 protections for information that is received or maintained by 8 the office of homeland security for use regarding the security 9 of critical infrastructure and protected systems, analysis, 10 warning, interdependency study, recovery, reconstitution or 11 other informational purposes. 12 SECTION 2. Chapter 128A, Hawaii Revised Statutes, is 13 amended by adding a new section to be appropriately designated 14 and to read as follows: 15 "§128A- Confidentiality of critical infrastructure 16 information. (a) Notwithstanding section 92F-11 and any other 17 law to the contrary, critical infrastructure information 18 received or maintained by the office of homeland security shall

1	be confidential and shall not be disclosed except as provided in
2	subsection (b).
3	(b) The office of homeland security may share confidential
4	critical infrastructure information received or maintained under
5	subsection (a) with federal agencies and state and county
6	agencies within the State for the purposes of the security of
7	critical infrastructure of protected systems; provided that the
8	information shall remain confidential and shall not be available
9	to the public."
10	SECTION 3. Section 128A-2, Hawaii Revised Statutes, is
11	amended by adding a new definition to be appropriately inserted
12	and to read as follows:
13	""Critical Infrastructure information" means information
14	not customarily in the public domain and related to the security
15	of critical infrastructure or protected systems, including
16	documents, records or other information concerning:
17	(1) Actual, potential, or threatened interference with,
18	attack on, compromise of, or incapacitation of
19	critical infrastructure or protected systems by either
20	physical or computer-based attack or other similar
21	conduct, including the misuse of or unauthorized
22	access to all types of communications and data

1		transmission systems, that violates federal, state,
2		local, or tribal law, harms interstate commerce of the
3		United States, or threatens public health or safety;
4	(2)	The ability of any critical infrastructure or
5		protected system to resist such interference,
6		compromise, or incapacitation, including any planned
7		or past assessment, projection, or estimate of the
8		vulnerability of critical infrastructure or a
9		protected system, including security testing, risk
10		evaluation thereto, risk-management planning, or risk
11		audit; or
12	(3)	Any planned or past operational problem or solution
13		regarding critical infrastructure or protected
14		systems, including repair, recovery, reconstruction,
15		insurance, or continuity, to the extent it is related
16		to such interference, compromise, or incapacitation."
17	SECT	ION 4. New statutory material is underscored.
18	SECT	ION 5. This Act shall take effect upon its approval.
