# A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION REVIEWS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that section 6E-8, Hawaii 2 Revised Statutes, plays an important role in the protection and 3 management of the State's historic properties and burial sites. 4 Section 6E-8(b) requires the department of Hawaiian home lands, 5 prior to any proposed project relating to lands under its 6 jurisdiction, to consult with the department of land and natural 7 resources regarding the effect of the project upon historic property or a burial site. 8

9 The purpose of this Act is to authorize the department of 10 Hawaiian home lands to assume review of the effect of any 11 proposed project on historic properties or burial sites for 12 lands under its jurisdiction.

SECTION 2. Section 6E-8, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: "(b) [The] Notwithstanding subsection (a), the department of Hawaiian home lands[, prior to] may assume review of any proposed project relating to lands under its jurisdiction[,
