A BILL FOR AN ACT

RELATING TO THE ELECTRIC BICYCLE AND ELECTRIC MOPED REBATE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 2 | SECTION 1. Part I of this Act is recommended by the |
| 3 | governor for immediate passage in accordance with section 9 of |
| 4 | article VII of the Constitution of the State of Hawaii. |
| 5 | SECTION 2. Act 306, Session Laws of Hawaii 2022, added a |
| 6 | new section to chapter 196, Hawaii Revised Statutes, that |
| 7 | created the electric bicycle and electric moped rebate program |
| 8 | and appropriated \$2,100,000 in general funds to the highway |
| 9 | development special fund electric bicycle and electric moped |
| 10 | subaccount to fund the rebate program in fiscal year 2022-2023. |
| 11 | However, such moneys were never allotted. Act 306 also |
| 12 | authorized the department of transportation to contract with a |
| 13 | third-party administrator to operate and manage the rebate |
| 14 | program. The purpose of the rebate program is to bring economic |
| 15 | relief to individuals by reducing the cost of living and cost of |
| 16 | transportation. Act 306, however, did not include an |
| 17 | appropriation out of the special fund to fund and implement the |

- 1 rebate program. Emergency funding is needed to fulfill the
- 2 legislative intent of Act 306, Session Laws of Hawaii 2022.
- 3 The purposes of part I this Act are to make an emergency
- 4 appropriation to the department of transportation to authorize
- 5 expenditure of funds for the electric bicycle and electric moped
- 6 rebate program, to authorize the payment of rebates to
- 7 individuals, and if necessary, to authorize payment to a third-
- 8 party administrator to operate and manage the electric bicycle
- 9 and electric moped rebate program.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$2,100,000 or so much
- 12 thereof as may be necessary for fiscal year 2022-2023 to be
- 13 deposited into the electric bicycle and electric moped special
- 14 fund established by part II of this Act.
- 15 The sum appropriated shall be expended by the department of
- 16 transportation for the purposes of Act 306, Session Laws of
- 17 Hawaii 2022, and this Act.
- 18 SECTION 4. There is appropriated out of the electric
- 19 bicycle and electric moped special fund established by part II
- 20 of this Act, the sum of \$2,100,000 or so much thereof as may be
- 21 necessary for fiscal year 2022-2023 for the operations of the
- 22 electric bicycle and electric moped rebate program including the

- 1 payment of rebates and the costs of the administrator; provided
- 2 that the department of transportation cannot expend more than
- 3 ten per cent of the total amount appropriated for the department
- 4 of transportation's administration of the electric bicycle and
- 5 electric moped rebate program; provided further that the funds
- 6 appropriated shall not lapse at the end of the fiscal year for
- 7 which it was appropriated, but any unencumbered funds remaining
- 8 shall lapse on June 30, 2024.
- 9 The sum appropriated shall be expended by the department of
- 10 transportation for the purposes of Act 306, Session Laws of
- 11 Hawaii 2022, and this Act.
- 12 PART II
- 13 SECTION 5. Part II of this Act authorizes a third-
- 14 party administrator to expend funds in the administration of the
- 15 electric bicycle and electric moped rebate program and to pay
- 16 the rebates to the rebate applicants; add a new section to
- 17 chapter 264, Hawaii Revised Statutes, to establish within the
- 18 state treasury the electric bicycle and electric moped special
- 19 fund for the purposes of funding the rebate program established
- 20 by Act 306, Session Laws of Hawaii 2022; and amend section 264-
- 21 122(d), Hawaii Revised Statutes, and section 2 of Act 306,
- 22 Session Laws of Hawaii 2022, to eliminate the highway

1 SECTION 7. Section 264-122, Hawaii Revised Statutes, is amended to read as follows: 2 3 "§264-122 Highway development special fund. (a) established in the state treasury the highway development 4 special fund to be administered by the department, into which 5 6 shall be deposited: 7 Transfers of county impact fees assessed under part (1)VIII of chapter 46 and this part to pay for state 8 9 highway improvements; 10 (2) Interest from investment of deposits; and 11 Legislative and county appropriations. (3) Moneys in the highway development special fund shall 12 (b) 13 be used for the following purposes: 14 Capital costs of qualifying proposed state highway 15 improvements; Reevaluation of the need, geographic limitations, 16 (2) 17 amount, and use of impact fees; Transfers to reimburse other special funds for 18 (3) expenditures which otherwise might have been funded 19 with moneys in the highway development special fund; 20 21 (4)Transfers under sections 36-27 and 36-30; Refunds under section 264-125; and 22 (5)

1 (6) The department's costs to implement this part, 2 including but not limited to costs to administer the 3 highway development special fund. 4 The department may establish accounts in the highway 5 development special fund as necessary to implement this part and 6 rules adopted by the department. 7 [(d) There is established within the highway development 8 special fund an electric bicycle and electric moped subaccount. 9 The department shall expend moneys in the subaccount for the 10 purposes of funding the electric bicycle and electric moped 11 rebate program established pursuant to section 196 .] " 12 SECTION 8. Act 306, Session Laws of Hawaii 2022, is 13 amended by amending section 2 to read as follows: 14 "SECTION 2. Chapter 196, Hawaii Revised Statutes, is 15 amended by adding a new section to part I to be appropriately 16 designated and to read as follows: 17 "§196-Electric bicycle and electric moped rebate 18 program; third-party administrator; special fund. The 19 department of transportation shall administer a rebate program that incentivizes the purchase of new electric bicycles and new 20 21 electric mopeds and may contract with a third-party

2 the rebate program. 3 (b) Each eligible purchase of a new electric bicycle or 4 new electric moped shall receive a rebate of either twenty per 5 cent of the retail cost or \$500, whichever amount is lower; 6 provided that no individual shall receive more than \$500 in 7 total rebates each fiscal year. 8 (C) The department of transportation shall not issue more 9 than \$700,000 in total rebates under this section each fiscal 10 year; provided that the electric bicycle and electric moped 11 [subaccount within the highway development] special fund 12 pursuant to section 264-122(d) contains sufficient funds to pay 13 the rebates. The department of transportation shall not be 14 liable to pay any refund if sufficient funds are unavailable. 15 The department of transportation shall allow valid claims filed 16 by eligible applicants for whom sufficient funds may not be 17 immediately available to receive a rebate as funds may be 18 available in a subsequent year. 19 (d) The department of transportation shall: 20 (1)Prepare any forms that may be necessary for an 21 applicant to claim a rebate pursuant to this section; 22 and

1 (i) The department of transportation may contract with a 2 third-party administrator to operate and manage the electric 3 bicycle and electric moped rebate program. The third-party 4 administrator shall not be deemed to be a "governmental body" as 5 defined in section 103D-104; provided that all moneys 6 transferred to the third-party administrator shall have been 7 appropriated by the legislature or shall be from moneys provided 8 by the federal government or private funding sources. The 9 third-party administrator shall not expend more than ten per 10 cent of the amounts appropriated for the rebate program, or any 11 other reasonable percentage determined by the department of 12 transportation, for administration of the electric bicycle and 13 electric moped rebate program. [4] 14 (j) Should the department of transportation contract with 15 a third-party administrator to administer the electric bicycle 16 and electric moped rebate program, the third-party administrator 17 shall be authorized to pay rebates to each rebate applicant from 18 moneys transferred pursuant to subsection (i) from the electric 19 bicycle and electric moped special fund." 20 SECTION 9. Statutory material to be repealed is bracketed 21 and stricken. New statutory material is underscored.

Report Title:

Emergency appropriation; Department of Transportation; Electric Bicycle and Electric Moped Rebate Program; Electric Bicycle and Electric Moped Special Fund.

Description:

Makes an emergency appropriation into and from a newly established special fund to authorize funds for the Department of Transportation Highways Division's Electric Bicycle and Electric Moped Rebate Program. Authorizes the Department of Transportation to pay a third-party administrator to administer and pay the rebates to the applicants.

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO THE ELECTRIC

BICYCLE AND ELECTRIC MOPED REBATE PROGRAM.

PURPOSE: Establish the Electric Bicycle and Electric

Moped Special Fund and eliminate the Highway Development Special Fund Electric Bicycle and Electric Moped subaccount. Make an emergency appropriation of general funds to implement the Electric Bicycle and Electric Moped

Rebate Program.

MEANS: Amend section 2 of Act 306, Session Laws of

Hawaii 2022, establish within the state treasury the Electric Bicycle and Electric Moped Special Fund and appropriate funds. Add a new section to part I of chapter 264, Hawaii Revised Statutes and amend section 264-122 of chapter 196, Hawaii Revised

Statutes, to eliminate the Highway

Development Special Fund Electric Bicycle and

Electric Moped Subaccount.

JUSTIFICATION: Act 306, Session Laws of Hawaii 2022

appropriated \$2,100,000 out of the general revenues of the State of Hawaii for fiscal year 2022-2023 to be deposited into the electric bicycle and electric moped

subaccount of the Highway Development Special Fund. However, such moneys were never allotted. In addition, Act 306 did not

authorize expenditure for payment of the rebates or appropriate funds for contracting

with the third-party administrator.

To remedy these issues, the purpose of this bill is to make an emergency appropriation into a newly established Electric Bicycle and Electric Moped Special Fund for fiscal year

2022-2023.

Making an emergency appropriation of general funds to authorize funds for the Department of Transportation's Electric Bicycle and

Electric Moped Rebate Program; appropriating funds to pay for rebates and authorizing the Department of Transportation to pay costs for a third-party administrator for the Electric Bicycle and Electric Moped Rebate Program is necessary to implement the rebate program.

Impact on the public: This bill will allow verified new electric bicycle and electric moped purchases by eligible individuals to receive a rebate of twenty per cent of the retail cost or \$500, whichever amount is lower, as an incentive to purchase electric bicycle and electric mopeds as an alternative form of transportation from gasoline powered vehicles.

Impact on the department and other agencies: This bill will allow the Department of Transportation's Highways Division to implement the new Electric Bicycle and Electric Moped Rebate Program.
