A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII RESIDENT TUITION FEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that facilitating 2 postsecondary education and training for all interested high 3 school graduates serves the State's interest. Postsecondary 4 options assist graduates by preparing them for jobs and career 5 pathways that typically pay higher wages, which enables them to 6 achieve their educational and career goals and afford the 7 State's high cost of living. Increased enrollment and 8 completion of postsecondary education and training will increase 9 the State's human capital. 10 The University of Hawaii amended its administrative rules 11 to streamline the enrollment process for all applicants for 12 admission into the University of Hawaii system; however, the 13 current statutory requirements regarding residency for tuition 14 purposes pose challenges for some local graduating high school 15 seniors or recent graduates. Specifically, some students 16 experiencing homelessness have difficulty providing evidence of 17 bona fide residency as required by statute, and students who 18 have complex family situations may be incorrectly considered

- 1 nonresidents. The legislature further finds that recognizing
 2 local high school graduates as residents to qualify for resident
 3 tuition fees would facilitate the enrollment of these students
- 4 at one of the University of Hawaii's campuses.
- 5 Accordingly, the purpose of this Act is to simplify the
- 6 residency determination for the State's high school graduates to
- 7 enroll in postsecondary education and training at the University
- 8 of Hawaii by considering graduates of the State's high schools
- 9 to be residents for tuition purposes.
- 10 SECTION 2. Section 304A-402, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- 12 "[+] §304A-402[+] Residence for tuition purposes; basic
- 13 rule. The board of regents shall adopt the necessary rules
- 14 defining residence for tuition purposes herein; provided that
- 15 the basic rule shall be that a student shall qualify for the
- 16 resident tuition fee only if the following criteria are met:
- 17 (1) The adult student, or in the case of a minor student,
 18 the student's parents or guardians, has or have been a
- bona fide resident of this State for at least twelve
- 20 consecutive months next preceding the student's first
- 21 day of officially scheduled instruction for any
- semester or term in which the student is enrolling at
- the particular college or campus; and

1	(2)	The adult or minor student has not been claimed as a	
2		dependent for tax purposes for at least twelve months	
3		next preceding the student's first day of officially	
4		scheduled instruction for any semester or term in	
5		which the student is enrolling at the particular	
6		college or campus by the student's parents or	
7		guardians who are nonresidents of the State; provided	
8		that this provision shall not apply in cases where the	
9		parent claiming the student as a dependent is entitled	
10		to do so under a child support order or agreement	
11		issued or entered into in conjunction with a divorce	
12		proceeding or legal separation agreement and the other	
13		parent and the student meet the criteria set forth in	
14		paragraph (1) [-] ; or	
15	(3)	The adult or minor student:	
16		(A) Graduated from high school in the State within	
17		two years preceding the student's first day of	
18		officially scheduled instruction for any semester	
19		or term in which the student is enrolling at the	
20		particular college or campus; and	
21		(B) Will enroll in an undergraduate degree program."

DEPARTMENT: University of Hawaii

TITLE: A BILL FOR AN ACT RELATING TO THE UNIVERSITY

OF HAWAII RESIDENT TUITION FEE.

PURPOSE: Requires the tuition residency rules for the

University of Hawaii (UH) to grant the resident tuition fee for enrollment at any UH campus to individuals who have graduated from a Hawaii high school and are enrolling in an undergraduate degree program, under

certain conditions.

MEANS: Amend section 304A-402, Hawaii Revised

Statutes.

JUSTIFICATION: The UH amended its administrative rules to

streamline the enrollment process for all applicants for admission into the UH system; however, the current statutory requirements regarding residency for tuition purposes pose challenges for some graduating high school seniors or recent graduates. Specifically, some students experiencing homelessness have difficulty providing evidence of bona fide residency, and

students who have complex family situations may be incorrectly considered nonresidents.

This measure will simplify the residency determination for the State's high school graduates to enroll in postsecondary education and training at the UH by considering soon-to-be and recent graduates of local high schools to be residents for tuition purposes.

Impact on the public: The UH anticipates that more local high school graduates would complete UH admissions applications at both community colleges and baccalaureate campuses due to a streamlined residency evaluation in the admissions application. Also, UH anticipates that more local applicants are likely to enroll if they are

determined to be residents when they are

accepted.

Impact on the department and other agencies:
The UH will need to revise its process for residency determination. The UH and the Department of Education will need to change

their communication with high school

students.
