### A BILL FOR AN ACT

RELATING TO OHANA ZONES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$15,000,000 or so
- 3 much thereof as may be necessary for fiscal year 2023-2024 and
- 4 the same sum or so much thereof as may be necessary for fiscal
- 5 year 2024-2025 for the ohana zones pilot program established
- 6 pursuant to Act 209, Session Laws of Hawaii 2018, as amended by
- 7 Act 128, Session Laws of Hawaii 2019, as amended by Act 235,
- 8 Session Laws of Hawaii 2022, including expenses relating to
- 9 operations, upkeep of facilities, provision of services, and
- 10 administrative costs.
- 11 The sums appropriated shall be expended by the office of
- 12 the governor for the purposes of this Act; provided that the
- governor shall transfer the expenditure authority to designated 13
- 14 executive branch departments or agencies within a reasonable
- 15 time.
- 16 The appropriations made by this Act for fiscal years 2023-
- 17 2024 and 2024-2025 for the office of the governor shall not

- 1 lapse at the end of the fiscal years for which the
- 2 appropriations are made; provided that all moneys from the
- 3 appropriations that are unencumbered as of June 30, 2026, shall
- 4 lapse as of that date.
- 5 Notwithstanding any other law to the contrary, the governor
- 6 may transfer all or a portion of the appropriation in this
- 7 section to the governor's designated executive branch agencies
- 8 for expenditures incurred in implementing the ohana zones pilot
- 9 program.
- 10 The governor's designated executive branch agencies may
- 11 expend any appropriation transferred pursuant to this section
- 12 for the performance of its duties under the ohana zones pilot
- 13 program.
- 14 SECTION 2. The director of finance is authorized to issue
- 15 general obligation bonds in the sum of \$15,000,000 or so much
- 16 thereof as may be necessary and the same sum or so much thereof
- 17 as may be necessary is appropriated for fiscal year 2023-2024
- 18 for the purpose of constructing facilities for the ohana zones
- 19 pilot program established pursuant to Act 209, Session Laws of
- 20 Hawaii 2018, as amended by Act 128, Session Laws of Hawaii 2019,
