# A BILL FOR AN ACT

RELATING TO HEALTH.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The department of health, department of human
2	services, and department of education shall research what rules,
3	policies, and plan amendments are necessary to ensure that
4	medically necessary services, including applied behavior
5	analysis services, for individuals twenty-six years of age or
6	younger with neurodevelopmental disorders, including autism
7	spectrum disorder and fetal alcohol spectrum disorders, are
8	covered under the following:
9	(1) The early and periodic screening, diagnostic, and
10	treatment benefit under the State's medicaid program;
11	(2) Any applicable state special education services and
12	programs; and
13	(3) The medicaid section 1915(c) home and community based
14	waiver for individuals with intellectual and
15	developmental disabilities.
16	SECTION 2. There is appropriated out of the general
17	revenues of the State of Hawaii the sum of \$ or so
