A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that traffic-related
- 2 deaths and fatalities in the State have significantly increased
- 3 over the past decade. In 2014, there were ninety-five deaths
- 4 and three hundred seventy-eight serious injuries in the State.
- 5 In 2019, Hawaii led the nation in pedestrian deaths of kupuna.
- 6 In 2022, these numbers grew to a record one hundred seventeen
- 7 deaths and five hundred seventy-two serious injuries. Hawaii's
- 8 students are also frequently hit by cars, and unfortunately all
- 9 too often seriously injured or killed while walking or biking to
- 10 school.
- 11 The legislature also finds that other places, including
- 12 cities of similar size and population to Honolulu, have
- 13 successfully reduced traffic-related fatalities to zero in some
- 14 years by making safety the top priority for project spending and
- 15 by investing in safer infrastructure accordingly.
- 16 However, the legislature recognizes that, in Hawaii,
- 17 decades of automobile-centric planning and development have



- 1 created formidable barriers to safe walking and bicycling,
- 2 especially for students and kupuna. These barriers include a
- 3 lack of complete, protected, and comfortable bike and pedestrian
- 4 networks; burdensome and complicated funding mechanisms for safe
- 5 routes projects; complicated coordination between state and
- 6 county agencies and community-based organizations to identify
- 7 and prioritize projects; and most of all, a lack of dedicated
- 8 funding. The legislature further finds that the safe routes to
- 9 school program itself is no longer working, as federal funding
- 10 has stalled, state funding has been separated from the program,
- 11 and engagement with community stakeholders has slowed.
- 12 Accordingly, the purpose of this Act is to re-prioritize
- 13 the safety of keiki and kupuna by fixing and simplifying the
- 14 safe routes to school program, establishing a program that
- 15 includes safe routes for all people, re-engaging community
- 16 stakeholders, and appropriating a meaningful \$50,000,000 to move
- 17 priority projects and save lives, by:
- 18 (1) Establishing within the department of transportation,
- a safe routes for people implementation program to
- 20 develop strategies and facilitate transportation-
- 21 related projects that will ensure that keiki and

1		kupuna are able to safely walk, bike, or roll to
2		common destinations through the Vision Zero policy
3		adopted by the department of transportation and county
4		transportation departments pursuant to
5		section 286-7.5, Hawaii Revised Statutes; the ground
6		transportation facilities plans developed and
7		implemented by the department of transportation and
8		counties pursuant to section 264-142, Hawaii Revised
9		Statutes; and the safe routes to school program under
10		section 291C-3, Hawaii Revised Statutes;
11	(2)	Establishing a safe routes for people implementation
12		committee to advise the State in carrying out the
13		purposes of the safe routes for people implementation
14		<pre>program;</pre>
15	(3)	Renaming the safe routes to schools special fund to
16		the safe routes for people special fund;
17	(4)	Authorizing the safe routes for people implementation
18		committee to develop an application process for
19		projects under the safe routes to school program and
20		determine awards for selected projects; and

1	(5) Appropriating \$50,000,000 for priority projects that
2	will improve bicyclist and pedestrian safety and allow
3	keiki and kupuna to safely walk, bike, or roll to
4	common destinations.
5	SECTION 2. Chapter 286, Hawaii Revised Statutes, is
6	amended by adding two new sections to be appropriately
7	designated and to read as follows:
8	"§286-A Safe routes for people implementation program;
9	establishment. There is established within the department for
10	administrative purposes only, a safe routes for people
11	implementation program to develop strategies and facilitate
12	transportation-related projects that will ensure that keiki and
13	kupuna are able to safely walk, bike, or roll to common
14	destinations through the Vision Zero policy adopted by the
15	department and county transportation departments pursuant to
16	section 286-7.5, ground transportation facilities plans
17	developed and implemented by the department and counties
18	pursuant to section 264-142, and projects authorized under the
19	safe routes to school program pursuant to section 291C-3.
20	§286-B Safe routes for people implementation committee.
21	(a) There is established within the department for

1	administr	ative purposes only, a safe routes for people
2	implement	ation committee to advise the State in carrying out the
3	purposes	of the safe routes for people implementation program.
4	Specifica	lly, the safe routes for people implementation
5	committee	shall:
6	(1)	Develop recommendations for any additional metrics or
7		benchmarks to ensure progress toward improving keiki
8		and kupuna safety by achieving the department's policy
9		goals and plans adopted and implemented pursuant to
10		sections 286-7.5 and 264-142;
11	(2)	Develop recommendations for federal and other grant
12		funding opportunities that may help achieve the
13		department's policy goals and plans adopted and
14		implemented pursuant to sections 286-7.5 and 264-142;
15	<u>(3)</u>	Develop recommendations to facilitate efforts by
16		communities to apply for and receive projects pursuant
17		to sections 286-7.5, 264-142, and 291C-3, and
18		streamline project development and implementation
19		between communities and the department;
20	(4)	Review project proposals and select priority projects
21		pursuant to sections 286-7.5, 264-142, and 291C-3 to

1		be funded through the safe routes for people
2		implementation program or otherwise be prioritized and
3		implemented by the department; and
4	<u>(5)</u>	Submit annual reports on the activities and
5		recommendations of the safe routes for people
6		implementation program to the governor and legislature
7		no later than December 31 of each year.
8	(b)	The safe routes for people implementation committee
9	shall con	sist of the following members:
10	(1)	The chairs of the house of representatives standing
11		committee and the senate standing committee having
12		primary jurisdiction over transportation, who shall
13		serve as co-chairs;
14	(2)	The deputy director of the department's highways
15		division;
16	(3)	The department's safe routes to school program
17		<pre>coordinator;</pre>
18	(4)	One member representing the physical activity and
19		nutrition section of the department of health's
20		chronic disease prevention and health promotion
21		division:

1	<u>(5)</u>	One member representing the department of education;
2	<u>(6)</u>	The chair of the Hawaii climate change mitigation and
3		adaptation commission;
4	(7)	One member representing the Hawaii state energy
5		office;
6	(8)	One member representing the Hawaii state council on
7		developmental disabilities;
8	(9)	One member representing each county department of
9		transportation;
10	(10)	One member representing an organization having a focus
11		on bicycling, who shall be invited to participate;
12	(11)	One member representing an organization having a focus
13		on senior citizens, who shall be invited to
14		participate;
15	(12)	One member representing an organization that
16		understands the ways in which families with young
17		children traverse the State, who shall be invited to
18		participate;
19	(13)	One member representing an organization having a focus
20		on public health and mobility, who shall be invited to
21		participate;

1	(14)	One member representing an organization having a focus
2		on transportation equity and mobility, who shall be
3		invited to participate; and
4	(15)	One member representing the Hawaii Association for
5		Independent Schools, who shall be invited to
6		participate.
7	<u>In a</u>	ddition to the members listed in this subsection, the
8	co-chairs	of the committee may request the participation or
9	input of	members of the public; experts in a related field;
10	county, s	tate, or federal officials; or others as necessary.
11	<u>(c)</u>	The members of the safe routes for people
12	implement	ation committee shall be nominated and, by and with the
13	advice an	d consent of the senate, appointed by the governor to
14	serve for	a term of three years each. Except as provided in
15	this sect	ion, the appointment, tenure, and removal of the
16	members a	and the filling of vacancies on the committee shall be
17	as provid	led in section 26-34.
18	<u>(d)</u>	Members of the safe routes for people implementation
19	committee	shall serve without compensation but shall be
20	reimburse	ed for expenses, including travel expenses, necessary
21	for the p	performance of their duties.

- 1 (e) No member of the safe routes for people implementation
- 2 committee shall be subject to chapter 84, solely because of the
- 3 member's service on the committee.
- 4 (f) As used in this section, "department" means the
- 5 department of transportation."
- 6 SECTION 3. Section 291-16, Hawaii Revised Statutes, is
- 7 amended by amending subsection (b) to read as follows:
- 8 "(b) The person shall pay the surcharge to the clerk of
- 9 the court. The surcharge shall be deposited with the director
- 10 of finance who shall credit the surcharge to the safe routes [to
- 11 school program] for people special fund established under
- 12 section 291C-4."
- 13 SECTION 4. Section 291C-3, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§291C-3 State [and county] safe routes to school
- 16 [programs;] program; coordinators; grants; reports. (a) There
- 17 is established, within the department of transportation, a safe
- 18 routes to school program that [shall], among other things, shall
- 19 enhance traffic safety around Hawaii's schools, enable and
- 20 encourage children to walk and bicycle to school, and make

- 1 bicycling and walking to school a safer and more appealing
- 2 transportation alternative.
- 3 (b) There is created, within the department of
- 4 transportation, the position of safe routes to school program
- 5 coordinator. The safe routes to school program coordinator
- 6 shall provide a central point of contact for the federal safe
- 7 routes to school program.
- 8 (c) [A county designated office, through the county safe
- 9 routes to school program coordinator, and in consultation with
- 10 the department of education, department of health, and Hawaii
- 11 Association of Independent Schools, shall provide safe routes to
- 12 school funds The safe routes for people implementation
- 13 committee shall develop recommendations for school-based and
- 14 community-based workshops and review project proposals and
- 15 select priority infrastructure and non-infrastructure projects
- 16 that will reduce vehicular traffic and congestion, encourage
- 17 walking and bicycling, and promote health and safety around
- 18 Hawaii's schools.
- 19 (d) The [legislature shall appropriate] department of
- 20 transportation, in conjunction with the safe routes for people
- 21 implementation committee, shall expend funds from the safe

9		on bicycle and pedestrian safety, or other
10		non-infrastructure activities as prescribed under
11		section 1404 of the 2005 Safe, Accountable,
12		Flexible, Efficient Transportation Equity Act: A
13		Legacy for Users, Public Law No. 109-59.
14	[-(£)- -	Each grant proposal in the county safe routes to
15	school pr	ogram shall:
16	(1)	Identify the modes of travel used by students to get
17		to-school;
18	(2)	Determine the number of students using each mode of
19		travel;
20	(3)	Survey the parents of each student to gather
21		information regarding the factors involved in the



I		choice of transportation mode for the student and,
2		where the student travels by automobile or bus,
3		conditions that would need to change for the parent to
4		permit the student to walk or ride a bicycle to

13	people im	plementation committee, in consultation with
14	organizat	ions that have received non-infrastructure and pending
15	infrastru	cture grants, shall develop a streamlined process for
16	the safe	routes to school program that meets federal and state
17	requireme	nts, simplifies the grant proposal application process,
18	and exped	ites release of funding after completion of
19	school-ba	sed and community-based projects for infrastructure and
20	non-infra	structure.

11	SECTION 6. Section 291C-5, Hawaii Revised Statutes, is
12	amended by amending subsection (b) to read as follows:
13	"(b) The person shall pay the surcharge to the clerk of
14	the court. The surcharge shall be deposited with the director
15	of finance who shall transmit the surcharge to the safe routes
16	[to school program] for people special fund established under
17	section 291C-4."
18	SECTION 7. Section 291C-104, Hawaii Revised Statutes, is
19	amended by amending subsection (c) to read as follows:
20	"(c) Any person who violates this section shall be fined
21	\$250, may be charged with a surcharge of up to \$100 to be

- 1 deposited into the trauma system special fund, and, where the
- 2 violation involves speeding in a school zone, shall be charged
- 3 with a surcharge of \$25 to be deposited into the safe routes [to
- 4 school program] for people special fund."
- 5 SECTION 8. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$50,000,000 or so
- 7 much thereof as may be necessary for fiscal year 2023-2024 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2024-2025 to fund priority projects identified by the safe
- 10 routes for people implementation committee to improve bicyclist
- 11 and pedestrian safety and allow keiki and kupuna to safely walk,
- 12 bike, or roll to common destinations.
- 13 The sums appropriated shall be expended by the department
- 14 of transportation for the purposes of this Act.
- 15 SECTION 9. In codifying the new sections added by
- 16 section 2 of this Act, the revisor of statutes shall substitute
- 17 appropriate section numbers for the letters used in designating
- 18 the new sections in this Act.
- 19 SECTION 10. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.
- 21 SECTION 11. This Act shall take effect on July 1, 2050.
