BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:


- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$648,000 or so much
- 3 thereof as may be necessary for fiscal year 2023-2024 as a grant
- 4 pursuant to chapter 42F, Hawaii Revised Statutes, to Hawaii
- 5 Theatre Center for construction for interior and exterior
- 6 lighting upgrades and replacement of the emergency lighting
- 7 transfer system.
- 8 The sum appropriated shall be expended by the department of
- 9 accounting and general services for the purposes of this
- 10 section.
- 11 SECTION 2. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 13 thereof as may be necessary for fiscal year 2023-2024 as a grant
- 14 pursuant to chapter 42F, Hawaii Revised Statutes, to Ka Lima O
- 15 Maui, Ltd., for construction of facilities.
- 16 The sum appropriated shall be expended by the department of
- 17 human services for the purposes of this section.

- 2 revenues of the State of Hawaii the sum of \$500,000 or so much
- 3 thereof as may be necessary for fiscal year 2023-2024 as a grant
- 4 pursuant to chapter 42F, Hawaii Revised Statutes, to Kauai
- 5 Habitat for Humanity, Inc., for construction of an affordable
- housing subdivision. 6
- 7 The sum appropriated shall be expended by the Hawaii
- 8 housing finance and development corporation for the purposes of
- 9 this section.
- 10 SECTION 4. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$414,000 or so much
- 12 thereof as may be necessary for fiscal year 2023-2024 as a grant
- 13 pursuant to chapter 42F, Hawaii Revised Statutes, to Central
- 14 Oahu Youth Services Association for plans, design, and
- 15 construction for phase two interior renovations of shelter
- 16 homes.
- 17 The sum appropriated shall be expended by the department of
- 18 human services for the purposes of this section.
- SECTION 5. This Act shall take effect on July 1, 2023. 19
