A BILL FOR AN ACT

RELATING TO LAW ENFORCEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 52D, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	" <u>§52D- Bias and cultural competency training.</u> (a) Each
6	police commission established pursuant to section 52D-1 shall
7	establish a training program that includes courses on cultural
8	competency, implicit bias, and racial and ethnic sensitivity.
9	Each police officer shall complete a minimum of hours of
10	training every years.
11	(b) For purposes of this section, "police officer" means
12	any public servant employed by a county, vested by law with a
13	duty to maintain public order or to make arrests for offenses or
14	to enforce the criminal laws, whether that duty extends to all
15	offenses or is limited to a specific class of offenses."

1	SECTION 2. Chapter 353C, Hawaii Revised Statutes, is			
2	amended by adding a new section to be appropriately designated			
3	and to read as follows:			
4	"§353C- Bias and cultural competency training. The			
5	department shall establish a training program that includes			
6	courses on cultural competency, implicit bias, and racial and			
7	ethnic sensitivity. Each law enforcement officer shall complete			
8	a minimum of hours of training every years."

10	SECTION 3. Chapter 52D, Hawaii Revised Statutes, is			
11	amended by adding a new section to be appropriately designated			
12	and to read as follows:			
13	" <u>§52D-</u> Police officers; training; persons with mental			
14	disabilities; crisis intervention. (a) Each police commission			
15	established pursuant to section 52D-1 shall ensure that every			
16	full-time police officer receives crisis intervention training			
17	relating to law enforcement interaction with persons with mental			
18	disabilities. The training shall include, at a minimum, eight			
19	hours of core instruction in the following:			
20	(1) The causes and nature of mental illnesses and			
21	developmental disabilities;

1	(2)	How to identify indicators of mental disability and
2		how to respond appropriately in a variety of common
3		situations;
4	(3)	Conflict resolution and de-escalation techniques for
5		potentially dangerous situations involving persons
6		with mental disabilities;
7	(4)	Appropriate language usage when interacting with
8		persons with mental disabilities;
9	(5)	Alternatives to lethal force when interacting with
10		potentially dangerous persons with mental
11		disabilities;
12	(6)	Community and state resources available to serve
13		persons with mental disabilities and how these
14		resources can be best utilized by law enforcement to
15		benefit persons with mental disabilities; and
16	(7)	The fact that pursuant to section 706-662(6)(b), a
17		crime committed against a victim because of an actual
18		or perceived disability of the victim is punishable by
19		an extended term of imprisonment.
20	<u>(b)</u>	Each police officer who completes the training
21	required	by this section shall obtain written proof of



1	completion of the training pursuant to procedures adopted by the
2	applicable police commission.
3	(c) Each police commission shall establish policies
4	relating to interaction between police officers and persons with
5	mental disabilities or homeless individuals. The training
6	provided pursuant to this section shall be consistent with the
7	policies established pursuant to this subsection.
8	(d) The training required by this section shall be
9	completed by December 31, 2025, for police officers employed
10	before January 1, 2025, and within twelve months of the date of
11	employment for all other police officers.
12	(e) For purposes of this section, "police officer" means
13	any public servant employed by a county, vested by law with a
14	duty to maintain public order or to make arrests for offenses or
15	to enforce the criminal laws, whether that duty extends to all
16	offenses or is limited to a specific class of offenses."

Police Commissions; Police Officers; Law Enforcement Officers; Bias and Cultural Competency; Persons with Mental Disabilities; Crisis Intervention; Training

Description:

Requires police commissions to establish and police officers to complete training programs on cultural competency and implicit bias and racial and ethnic sensitivity. Requires the Department of Law Enforcement to establish and law enforcement officers to complete training programs on cultural competency and implicit bias and racial and ethnic sensitivity. Requires police commissions to ensure that all full-time police officers receive crisis intervention training related to interaction with persons with mental disabilities. Requires police commissions to establish policies for officer interaction with persons with mental disabilities and homeless persons.
