A BILL FOR AN ACT

RELATING TO ELECTRIC GRID RESILIENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that in September 2017, SECTION 1. 2 Hurricanes Irma and Maria struck Puerto Rico with devastating 3 force, causing an estimated \$95,000,000,000 in damages to the island, including extensive damages to the island's electrical 4 5 infrastructure. The legislature further finds that a direct hit on Oahu from a similar category five hurricane would almost 6 7 certainly cause extensive property damage and extended power 8 outages across the island. Moreover, much of the State's 9 energy-generating infrastructure is susceptible to storm surges due to the structures being located at or near coastlines. 10 The Hawaii emergency management agency estimates that under a best-11 12 case scenario, it would take at least fourteen days after 13 landfall of a category four hurricane on Oahu to restore eighty per cent of grid power. Most public emergency shelters in the 14 State do not have the capacity to provide two weeks of 15 16 electrical service, and relief from the mainland is dependent upon a functioning airport and seaport. Furthermore, the risks 17

of a natural disaster increase with the impacts of climate
 change.

The legislature also finds that the Lahaina fire of August 2023 was the worst natural disaster in the history of Hawaii. As the effects of climate change become more pronounced and the rate of severe fires increases, Hawaii must have electrical grids that can withstand these extreme events.

8 The legislature hereby declares that it shall be the policy 9 of the State to ensure that the State is prepared to withstand 10 natural disasters and other emergencies and protect the State's 11 critical infrastructure and its citizens by making investments 12 in grid resiliency. The goals of this policy are to:

13 (1) Prevent or reduce the severity of damage to the
14 electric grid from a natural disaster or state of
15 emergency;

16 (2) Enable faster recovery of normal grid operations after
17 a grid outage due to a natural disaster or state of
18 emergency; and

19 (3) Maintain critical loads at critical infrastructure,
20 such as hospitals, fire stations, police stations,

1	airports, and seaports during a grid outage due to a
2	natural disaster or state of emergency.
3	The purpose of this Act is to create a homeland security
4	and resiliency council to identify electric grid and other
5	critical infrastructure needs and provide recommendations for
6	enhancing grid and critical infrastructure resiliency throughout
7	the State.
8	SECTION 2. Chapter 128A, Hawaii Revised Statutes, is
9	amended by adding a new section to be appropriately designated
10	and to read as follows:



1	SECTION 3. Section 128A-2, Hawaii Revised Statutes, is
2	amended by adding three new definitions to be appropriately
3	inserted and to read as follows:
4	"Critical infrastructure sector" means a sector whose
5	assets, systems, and networks, whether physical or virtual, are
6	vital to the State's security, economic security, public health
7	or safety, or any combination thereof, including but not limited
8	to the water, transportation, electrical energy, fuel import and
9	refining, and communications sectors.
10	"Electric grid" means the network of electric generators,
11	transmission and distribution lines, substations, energy storage
12	devices, and supporting infrastructure used to produce and
13	deliver electricity to end-users.
14	"Resiliency" means the capacity to prevent or reduce the
15	severity of damage from natural disaster or manmade emergencies,
16	and to enable faster recovery of normal infrastructure
17	operations after a natural disaster or manmade emergency."
18	SECTION 4. In accordance with section 9 of article VII of
19	the Hawaii State Constitution and sections 37-91 and 37-93,
20	Hawaii Revised Statutes, the legislature has determined that the
21	appropriations contained in Act 164, Regular Session of 2023,

1	and this Act will cause the state general fund expenditure
2	ceiling for fiscal year 2024-2025 to be exceeded by
3	\$ or per cent. This current declaration takes
4	into account general fund appropriations authorized for fiscal
5	year 2024-2025 in Act 164, Regular Session of 2023, and this Act
6	only. The reasons for exceeding the general fund expenditure
7	ceiling are that:
8	(1) The appropriation made in this Act is necessary to
9	serve the public interest; and
10	(2) The appropriation made in this Act meets the needs
11	addressed by this Act.
12	SECTION 5. There is appropriated out of the general
13	revenues of the State of Hawaii the sum of \$ or so
14	much thereof as may be necessary for fiscal year 2024-2025 for
15	the homeland security and resiliency council to perform its
16	duties under chapter 128A, Hawaii Revised Statues.
17	The sum appropriated shall be expended by the office of
18	homeland security for the purposes of this Act.
19	SECTION 6. New statutory material is underscored.
20	SECTION 7. This Act shall take effect on January 1, 2042.
