A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that wildfires are a
- 2 serious threat in the State. Wildfires can harm native
- 3 ecosystems that are not typically equipped or developed to
- 4 handle frequently-occurring fires. When forests in the State
- 5 are damaged by wildfires, the ecosystem does not regenerate the
- 6 lost plant life; instead, invasive species and fire-prone
- 7 grasses can take over native forests. The results of wildfire
- 8 destruction can be far-reaching, as reductions in native forests
- 9 can lead to decreased water quality, increased erosion, and
- 10 damage to coral reefs from sedimentation and nutrient loading.
- 11 Hawaii is also home to a unique array of native plants and
- 12 animals, with some species found nowhere else in the world.
- 13 Protecting the State's forests from wildfires will protect the
- 14 habitats for these native species.
- 15 The legislature also finds that the wildfire management
- 16 branch of the department of land and natural resources division
- 17 of forestry and wildlife is severely underfunded. The wildfire

- 1 management branch provides grants for and works with the
- 2 nonprofit, Hawaii Wildfire Management Organization. The
- 3 wildfire management branch does not have the staffing capacity
- 4 or resources to adequately provide programming for all the
- 5 State's wildfire preparedness needs, and instead partners with
- 6 nonprofit organizations such as the Hawaii Wildfire Management
- 7 Organization to fill this gap.
- 8 The legislature further finds that wildfire prevention
- 9 nonprofits cannot count on receiving grant funding annually from
- 10 the wildfire management branch and are often outcompeted by
- 11 larger, national nonprofits for federal grants. Therefore, it
- 12 is necessary to secure permanent funding to support nonprofit
- 13 partners that provide education, training, and support for large
- 14 landowners to manage fire risks through mitigation plans and
- 15 projects.
- Accordingly, the purpose of this Act is to make an
- 17 appropriation for the wildfire management branch of the
- 18 department of land and natural resources division of forestry
- 19 and wildlife to support nonprofit organizations that specialize
- 20 in wildfire preparedness and mitigation programming through
- 21 grant disbursements.

- 1 SECTION 2. In accordance with section 9 of article VII of
- 2 the Hawaii State Constitution and sections 37-91 and 37-93,
- 3 Hawaii Revised Statutes, the legislature has determined that the
- 4 appropriations contained in Act 164, Regular Session of 2023,
- 5 and this Act will cause the state general fund expenditure
- 6 ceiling for fiscal year 2024-2025 to be exceeded by
- 7 \$ or per cent. This current declaration takes
- 8 into account general fund appropriations authorized for fiscal
- 9 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 10 only. The reasons for exceeding the general fund expenditure
- 11 ceiling are that:
- 12 (1) The appropriation made in this Act is necessary to
- serve the public interest; and
- 14 (2) The appropriation made in this Act meets the needs
- addressed by this Act.
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2024-2025 for
- 19 the wildfire management branch of the department of land and
- 20 natural resources division of forestry and wildlife to provide

- 1 grants to nonprofit organizations that specialize in wildfire
- 2 preparedness and mitigation programming.
- 3 The sum appropriated shall be expended by the department of
- 4 land and natural resources for the purposes of this Act.
- 5 SECTION 4. Beginning with fiscal year 2024-2025 and each
- 6 fiscal year thereafter, the department of land and natural
- 7 resources shall include in its annual budget request line-item
- 8 funding for the wildfire management branch. To ensure increased
- 9 wildfire preparedness, the amount of funding requested shall
- 10 scale proportionally with the number of organizations receiving
- 11 grants through the wildfire management branch program.
- 12 SECTION 5. This Act shall take effect on July 1, 2050.
