RELATING TO AGRICULTURAL LAND USE POTENTIAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1.	The legislature finds that the State needs to
2	become self-sufficient in growing its own food, as eighty-five	
3	to ninety per cent of the State's food is imported.	
4	The legislature further finds that forty-two per cent of	
5	the State's agricultural land is currently unfarmed and that the	
6	government is th	e largest landowner in the State, owning over
7	1,600,000 acres out of the 4,100,000 acres of total land in the	
8	State.

Requires the Department of Agriculture to: (1) identify and evaluate each parcel of certain state-owned lands; and (2) contract a third-party entity to compile a report evaluating the agricultural land use potential of each parcel of state-owned lands greater than five acres, excluding commercial, residential, and department of education lands. Requires a report. Declares that the general fund expenditure ceiling is exceeded. Makes an appropriation. (SD1)
