### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	(b) For purposes of this section, the length of term of an
2	office shall be the usual length of term of the office as
3	unaffected by reapportionment, a special election to fill a
4	vacancy, or any other factor causing the term of the office the
5	candidate is seeking to be less than the usual length of term of
6	that office.
7	(c) During any regular session or special session of the
8	legislature, including any extension of any regular session or
9	special session and any legislative recess days, holiday, or
10	weekend, no elected official as defined in section 11-342(d)
11	shall solicit or accept any campaign contribution."
12	SECTION 2. This Act does not affect rights and duties that
13	matured, penalties that were incurred, and proceedings that were
14	begun before its effective date.
15	SECTION 3. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 4. This Act shall take effect upon its approval.
