BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 710-1040, Hawaii Revised Statutes, is 2 amended by amending subsection (4) to read as follows: 3 Bribery is a class B felony[-]; provided that bribery is a class A felony if: 4 5 The public servant is an elected or appointed (a) 6 official; 7 The value, or aggregate value, of the pecuniary (b) benefit described in subsection (1)(a) or (1)(b) 8 9 exceeds \$20,000; or The person commits three or more acts of bribery as 10 (c) described in subsection (1)(a) or (1)(b) in a 11 12 three-year period. (5) A person convicted of violating this section, 13 notwithstanding any law to the contrary, shall not be eligible 14 for a deferred acceptance of guilty plea or nolo contendere plea 15 16 under chapter 853."
