#### A BILL FOR AN ACT

#### PROPOSING AMENDMENTS TO ARTICLE III OF THE HAWAII STATE CONSTITUTION TO ESTABLISH A CONTINUOUS LEGISLATIVE SESSION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Hawaii's state
 legislature only has sixty session days per year, generally
 stretching from the middle of January until early May. The
 legislature notes that the representatives and senators who
 comprise the state legislature are part-time employees of the
 State.

7 The legislature further finds that the efficiency, 8 productivity, orderliness, and transparency of the state 9 legislature could be improved by requiring that the legislature 10 be in session during every month of the year. The legislature 11 notes that doing so would make the representatives and senators 12 who comprise the state legislature into full-time employees of 13 the State.

14 The purpose of this Act is to propose amendments to article
15 III of the Constitution of the State of Hawaii to establish a
16 continuous legislative session. Specifically, this Act:

Any 2 session may be recessed by concurrent resolution adopted by a majority of the members to which each house is entitled. 3 Saturdays, Sundays, -holidays, the days in mandatory recess and 4 5 any days in recess pursuant to a concurrent resolution shall be 6 excluded in computing the number of days of any session.] 7 All [sessions] meetings shall be held in the capital of the State. In case the capital shall be unsafe, the governor may 8 9 direct that any [session] meeting be held at some other place." 10 SECTION 5. Article III, section 12, of the Constitution of 11 the State of Hawaii is amended to read as follows: 12 "ORGANIZATION; DISCIPLINE; RULES; PROCEDURE 13 Section 12. Each house shall be the judge of the 14 elections, returns and qualifications of its own members and shall have, for misconduct, disorderly behavior or neglect of 15 duty of any member, power to punish [such] the member by censure 16 or, upon a two-thirds vote of all the members to which [such] 17 the house is entitled, by suspension or expulsion of [such] the 18 19 member. Each house shall choose its own officers, determine the rules of its proceedings and keep a journal. The ayes and noes

1 of the members on any question shall, at the desire of one-fifth of the members present, be entered upon the journal. 2 3 Twenty days after a bill has been referred to a committee 4 in either house, the bill may be recalled from [such] the 5 committee by the affirmative vote of one-third of the members to 6 which [such] the house is entitled. 7 Every meeting of a committee in either house or of a 8 committee comprised of a member or members from both houses held 9 for the purpose of making decision on matters referred to the 10 committee shall be open to the public. 11 [By rule of its proceedings, applicable to both houses, 12 each house shall provide for the date by which all bills to be 13 considered in a regular session shall be introduced.] " 14 SECTION 6. No bill shall 18 19 pass third or final reading in either house unless printed 20 copies of the bill in the form to be passed shall have been made

available to the members of that house for at least forty-eight
 hours.

Every bill when passed by the house in which it originated,
or in which amendments thereto shall have originated, shall
immediately be certified by the presiding officer and clerk and
sent to the other house for consideration.

7 [Any bill pending at the final adjournment of a regular session in an odd-numbered year shall carry over with the same 8 status to the next regular session. - Before the carried over 9 10 bill is enacted, it shall pass at least one reading in the house in which the bill originated.] The annual budget shall pass each 11 12 house and be submitted for gubernatorial consideration forty-13 five days before the end of the preceding fiscal year. Any 14 bill, except for the annual budget bill, shall have two calendar years after introduction to pass each house and be submitted for 15 gubernatorial consideration. If the last day of the period 16 17 within which the bill is required to be submitted for 18 qubernatorial consideration falls on a Saturday, Sunday or 19 holiday, the period shall extend to the next day that is not a Saturday, Sunday or holiday." 20



Report Title: Continuous Legislative Session; Constitutional Amendment; Constitutional Repeal

#### Description:

Establishes a continuous Legislature. Requires the Legislature to convene at least once a month. Removes language regarding special sessions, adjournment, and recesses. Creates a two-year deadline for a bill to be submitted for gubernatorial consideration. Standardizes the number of days that the Governor must approve or veto a bill submitted for consideration. Requires the passage of the legislative budget within 45 days before the end of each fiscal year. Makes members of the Legislature subject to the sunshine law. Prohibits members of the Legislature from having employment other than their work as members of the Legislature.
