
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 188-31, Hawaii Revised Statutes, is
 amended to read as follows:

3 "\$188-31 Permits to take aquatic life for aquarium
4 purposes. (a) Except as prohibited by law, the department,
5 upon receipt of a written application, may issue an aquarium
6 fish permit, not longer than one year in duration, to use fine
7 meshed traps, or fine meshed nets other than throw nets, for the
8 taking of marine or freshwater nongame fish and other aquatic
9 life for aquarium purposes.

10 (b) Except as prohibited by law, the permits shall be 11 issued only to persons who can satisfy the department that they 12 possess facilities to and can maintain fish and other aquatic 13 life alive and in reasonable health.

(c) It is unlawful for any person to use nets made of or
using netting with a stretched mesh of less than two inches,
except that aquarium fish collectors with a valid aquarium fish
permit issued pursuant to this section may use traps and nets

2	conditions of the permit; provided that non-commercial aquarium
3	fish collectors shall be limited to a combined total of five
4	fish or aquatic life specimens per person per day. Any person
5	violating this subsection shall be subject to penalty as

7	shall constitute a separate offense.
8	[(c)] <u>(d)</u> It shall be illegal to sell or offer for sale
9	any fish and other aquatic life taken under an aquarium fish
10	permit unless those fish and other aquatic life are sold alive
11	for aquarium purposes.
12	The department may adopt rules pursuant to chapter 91 for
13	the purpose of this section.
14	[(d)] <u>(e)</u> For the purposes of this section:
15	(1) "Aquarium purposes" means to hold salt water fish,
16	freshwater nongame fish, or other aquatic life alive
17	in a state of captivity as pets, for scientific study,
18	or for public exhibition or display, or for sale for
19	these purposes; and
20	(2) "Aquarium fish permit" means a permit issued by the
21	board for the use of fine mesh nets and traps to take

Report Title:

Aquarium Fish Permits; Nets; Non-commercial Aquarium Fish Collectors; Limits

Description:

Establishes that it shall be unlawful for any person to use nets made of or using netting with a stretched mesh of less than two inches, except that aquarium fish collectors with a valid aquarium fish permit may use traps and nets for aquarium fish and other aquatic life in conformance with the permit; provided that non-commercial aquarium fish collectors shall be limited to a combined total of five fish or aquatic life specimens per person per day. Establishes penalties.
