A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that state law requires a
- 2 police officer employed after June 30, 2012, to meet both age
- 3 and years of service requirements for retirement. An officer
- 4 hired after this date is required to have twenty-five years of
- 5 service and have attained fifty-five years of age. According to
- 6 a study by the National Center for Biotechnology Information,
- 7 the years of potential life lost for police officers are
- 8 twenty-one times greater than that of the general population.
- 9 Police officers generally have shorter life expectancy due to
- 10 stress, shift work, obesity, and exposure to hazardous work
- 11 environments. The study also found that a male police officer
- 12 who reached fifty years of age between 1950 and 2005 was
- 13 expected to live only 7.8 additional years, while a male in the
- 14 general population of the United States that reached fifty years
- 15 of age in the same time period was expected to live an
- 16 additional thirty-five years. Further, male police officers
- 17 fifty to fifty-four years of age had a nearly forty per cent

- 1 probability of death compared to a one per cent probability for "
- 2 males in the general population in the same age category.
- 3 The legislature further finds that, upon considering the
- 4 results of this study, eliminating the minimum retirement age
- 5 requirement for police officers and maintaining the twenty-five
- 6 years of service requirement may help to reduce the mortality
- 7 rate risk factor for police officers. For example, an officer
- 8 who joins the police department at twenty years of age would
- 9 have the option to retire at forty-five years of age, which
- 10 would significantly reduce the possibility of health risk
- 11 factors associated with police work. Additionally, the Honolulu
- 12 and Maui police departments have developed a lateral transfer
- 13 program to attract former officers from Hawaii or elsewhere to
- 14 transfer to Honolulu or Maui, but the retirement requirements of
- 15 twenty-five years of service and minimum age of fifty-five
- 16 discourage many qualified individuals from transferring.
- 17 The purpose of this Act is to provide an incentive to
- 18 recruit and retain more police officers.
- 19 SECTION 2. Section 88-73, Hawaii Revised Statutes, is
- 20 amended by amending subsection (a) to read as follows:
- "(a) Any member who:

1	(1)	Became a member before July 1, 2012, and has at least
2		five years of credited service and has attained age
3		fifty-five;
4	(2)	Became a member before July 1, 2012, and has at least
5		twenty-five years of credited service;
6	(3)	Has at least ten years of credited service, which
7		includes service as a judge before July 1, 1999, an
8		elective officer, or a legislative officer;
9	(4)	Becomes a member after June 30, 2012, and has at least
10		ten years of credited service and has attained age
11		sixty; or
12	(5)	Becomes a member after June 30, 2012, and has at least
13		twenty-five years of credited service [and has
14		attained age fifty five],
15	shall become eligible to receive a retirement allowance after	
16	the member has terminated service."	
17	SECTION 3. Section 88-99, Hawaii Revised Statutes, is	
18	amended to read as follows:	
19	"[{]§88-99[}] Moratorium on benefit enhancements. There	
20	shall be no benefit enhancements under this chapter for any	
21	group of members, including any reduction of retirement age,	

- 1 until [such time as] the actuarial value of the system's assets
- 2 is one hundred per cent of the system's actuarial accrued
- 3 liability [-]; provided that any prohibition on the reduction of
- 4 retirement age shall not apply to any member subject to section
- 5 88-73(a)(5)."

- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.
