BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 2. Section 302A-405, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 2 3 [The] Except as provided in section 302A-404(b) and 4 (c), the price for school meals shall be set by the department 5 to ensure that moneys received from the sale of the meals shall 6 be [not] no less than one-half of the cost of preparing the meals. The prices for school meals may be adjusted annually 7 8 based on the previous year's costs rounded to the nearest five 9 cents; provided that the department by rule shall provide a 10 lower rate or free meals to children based on their economic 11 need." 12 SECTION 3. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$ 14 much thereof as may be necessary for fiscal year 2024-2025 to 15 the Hawaii child nutrition programs for the total plate costs 16 associated with providing universal free school breakfasts and 17 lunches in department of education schools as required by this 18 Act after federal funding has been accounted. 19 The sum appropriated shall be expended by the department of

education for the purposes of this Act.

- SECTION 4. In accordance with section 9 of article VII of 1 2 the Hawaii State Constitution and sections 37-91 and 37-93, Hawaii Revised Statutes, the legislature has determined that the 3 appropriations contained in H.B. No. , will cause the state 4 general fund expenditure ceiling for fiscal year 2024-2025 to be 5 6 exceeded by \$ or per cent. In addition, the appropriation contained in this Act will cause the general fund 7 expenditure ceiling for fiscal year 2024-2025 to be further 8 9 exceeded by \$ per cent. The combined total or 10 amount of general fund appropriations contained in only these 11 two Acts will cause the state general fund expenditure ceiling for fiscal year 2024-2025 to be exceeded by 12 per cent. The reasons for exceeding the 13 general fund expenditure ceiling are that: 14 The appropriation made in this Act is necessary to 15 (1)serve the public interest; and 16 The appropriation made in this Act meets the needs 17 (2) addressed by this Act. 18
- SECTION 6. This Act shall take effect on July 1, 2024.
