A BILL FOR AN ACT

RELATING TO VEHICLE TITLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-52, Hawaii Revised Statutes, is
- 2 amended as follows:
- 3 1. By amending subsection (b) to read:
- 4 "(b) Within thirty calendar days thereafter, the
- 5 transferee shall forward the certificate of ownership so
- 6 endorsed to the director of finance who shall file the same;
- 7 provided that if the recorded lien holder does not have an
- 8 office in the State, the applicable period shall be sixty days.
- 9 Whenever a transferee fails to comply with these provisions, the
- 10 director of finance shall charge a fee of \$50, in addition to
- 11 the fee provided in section 286-51, for a new certificate of
- 12 ownership. If after thirty calendar days, or sixty days as
- 13 appropriate, the transferee has not forwarded the endorsed
- 14 certificate of ownership, the transferor may submit an
- 15 attestation about the transfer that includes the names and
- 16 addresses of the transferor and transferee, date of transfer,
- 17 vehicle description, and date that the notice required pursuant

- 1 to subsection (j) was submitted to the director of finance, who
- 2 shall treat the attestation in the same manner as an endorsed
- 3 certificate."
- 4 2. By amending subsection (d) to read:
- 5 "(d) The director of finance, upon receipt of the
- 6 certificate of ownership properly endorsed, or the transferor's
- 7 attestation pursuant to subsection (b), shall register the
- 8 vehicle, and shall issue to the owner and legal owner entitled
- 9 thereto by reason of the transfer a new certificate of
- 10 registration and the certificate of ownership, respectively, in
- 11 the manner and form hereinabove provided for original
- 12 registration."
- 3. By amending subsection (k) to read:
- "(k) Whenever the registered owner of any motor vehicle or
- 15 any licensed dealer has given notice to the director of finance
- 16 of a transfer of the title or interest in the motor vehicle, as
- 17 provided in subsection (i) or (j), and has delivered the
- 18 certificate of ownership bearing the transferor's signature to
- 19 the transferee as required by subsection (a) $[\tau]$ or the
- 20 transferor's attestation pursuant to subsection (b), the
- 21 transferor shall be relieved from any liability, civil or

- 1 criminal, from the date the transferor delivers the motor
- 2 vehicle into the transferee's possession, which the transferor
- 3 might otherwise subsequently incur by reason solely of being the
- 4 registered owner of the vehicle."
- 5 4. By amending subsection (m) to read:
- 6 "(m) Any person who falsely or fraudulently gives notice
- 7 to the director of finance of a transfer of title or interest in
- 8 a motor vehicle or who falsely or fraudulently provides an
- 9 attestation pursuant to subsection (b) shall be subject to the
- 10 penalty provided in section 286-61."
- 11 SECTION 2. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 3. This Act shall take effect upon its approval.
