### A BILL FOR AN ACT

AMENDING ARTICLE XVI, SECTION 3, OF THE CONSTITUTION OF THE STATE OF HAWAII TO PREVENT CERTAIN INDIVIDUALS FROM SERVING IN PUBLIC OFFICE OR EMPLOYMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that citizens of this
- 2 State have the right to expect that public servants be people of
- 3 integrity, and not people who have committed actions that
- 4 threaten democracy or undermine the vote of the people.
- 5 The purpose of this Act is to propose to amend article XVI,
- 6 section 3, of the Constitution of the State of Hawaii to more
- 7 closely reflect the language of Section 3 of the Fourteenth
- 8 Amendment to the Constitution of the United States.
- 9 SECTION 2. Article XVI, section 3, of the Constitution of
- 10 the State of Hawaii is amended to read as follows:
- 11 "DISQUALIFICATIONS FROM PUBLIC OFFICE OR EMPLOYMENT
- 12 Section 3. No person shall hold any elected office for
- 13 this State or any portion of this State, or serve as an elector
- 14 of the president or vice president, or hold any other public
- 15 office or employment, either as a civilian or a member of the
- 16 Hawaii national guard or successor entity, who [has been

- 1 convicted of any act to overthrow, or attempt to overthrow, or
- 2 conspiracy with any person to overthrow the government of this
- 3 State or of the United States by force or violence.], having
- 4 previously sworn or affirmed to support the Constitution of the
- 5 United States, the Constitution of the State of Hawaii, or the
- 6 constitution of any other state, shall have engaged in
- 7 insurrection or rebellion against the same, or given aid or
- 8 comfort to the enemies thereof."
- 9 SECTION 3. The question to be printed on the ballot shall
- 10 be as follows:
- 11 "Shall article XVI, section 3, of the Constitution of the
- 12 State of Hawaii, which disqualifies certain persons from public
- 13 office or employment, be amended to more closely reflect the
- 14 language of Section 3 of the Fourteenth Amendment to the
- 15 Constitution of the United States, and not explicitly require
- 16 that a person be convicted of any act to overthrow, attempt to
- 17 overthrow, or conspiracy with any person to overthrow the
- 18 government of this State or the United States by force or
- 19 violence?"
