A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that state agricultural
- 2 lands are a key resource that can be used to meet the State's
- 3 goals for economic diversification and food self-sufficiency.
- 4 In order to support farmers on these lands, the State subsidizes
- 5 lessees by providing the leases below market rates and, in some
- 6 cases, providing lower-cost agricultural water. Despite these
- 7 state subsidies, some state agricultural leases are used
- 8 primarily as residences or non-agricultural businesses or are
- 9 unused.
- 10 The legislature further finds that lessees who obtain a
- 11 state agricultural lease in high-demand locations can transfer
- 12 the remainder of their lease to the highest bidder, thereby
- 13 converting their lease into a windfall profit above and beyond
- 14 their investment in the property. This windfall profit is an
- 15 unintended transfer of wealth from the State to individual
- 16 lessees. This situation also causes the transfers of leases to
- 17 the highest bidder, who may or may not be the farmers best able

- 1 to use the land for agricultural production. The legislature
- 2 believes that further data is needed to assess to what extent
- 3 the department of agriculture leases maximize the benefit to the
- 4 State of these lands to help the State achieve its economic and
- 5 food production goals. Further data is also needed to assess
- 6 whether the transfer of state lands from one lessee to another
- 7 results in the difference between the actual value of the lease
- 8 and the subsidized price of the lease being monetized for
- 9 private, rather than State, benefit.
- 10 Accordingly, the purpose of this Act is to require the
- 11 board of agriculture to submit a report on the percentages of
- 12 agricultural lands being leased by the State that are suitable
- 13 for farming and actively being used for farming purposes and
- 14 certain dollar amounts relating to lease transfers between
- 15 lessees.
- 16 SECTION 2. The board of agriculture shall submit to the
- 17 legislature no later than twenty days prior to the convening of
- 18 the regular session of 2025 a report of:
- 19 (1) The percentage of each tax map key of agricultural
- 20 lands that are leased by the State pursuant to section
- 21 166-11, Hawaii Revised Statutes, that are:

1	(A) Suitable for farming; and
2	(B) Actively being farmed; and
3	(2) For every lease entered into pursuant to section
4	166-11, Hawaii Revised Statutes, that was transferred
5	by a lessee to another lessee, the dollar amounts of
6	the following:
7	(A) Lease rent;
8	(B) Cost of infrastructure improvements made by the
9	original lessee;
10	(C) Sum paid by the purchaser of the remainder of the
11	lease; and
12	(D) Amount from the sum paid by the purchaser that
13	goes to the State.
14	SECTION 3. This Act shall take effect upon its approval.
