A BILL FOR AN ACT

RELATING TO BURIAL SITES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the lack of an		
2	objective certification, selection or evaluation process for		
3	historic preservation professionals allows developers to		
4	purchase services that produce plans and reports mandated in the		
5	historic preservation review process, which accommodate their		
6	development interests.		
7	Therefore, the purpose of this Act is to:		
8	(1) Require the State historic preservation division to		
9	compile a list of archaeological professionals		
10	approved by the department to ensure the quality and		
11	integrity of archaeological services contracted by		
12	developers; and		
13	(2) Specify information to be included in an		
14	archaeological inventory survey.		
15	SECTION 2. Section 6E-42, Hawaii Revised Statutes, is		
16	amended to read as follows:

1	"§6E-42 Review of proposed projects. (a) Except as		
2	provided in section 6E-42.2, before any agency or officer of the		
3	State or its political subdivisions approves any project		
4	involving a permit, license, certificate, land use change,		
5	subdivision, or other entitlement for use, which may affect		
6	historic property, aviation artifacts, or $[a]$ burial sites, the		
7	agency or office shall advise the department and prior to any		
8	approval allow the department an opportunity for review and		
9	comment on the effect of the proposed project on historic		
10	properties, aviation artifacts, or burial sites, consistent with		
11	section 6E-43, including those listed in the Hawaii register of		
12	historic places. If:		
13	(1) The proposed project consists of corridors or large		
14	land areas;		
15	(2) Access to properties is restricted; or		
16	(3) Circumstances dictate that construction be done in		
17	stages,		
18	the department's review and comment may be based on a phased		
19	review of the project; provided that there shall be a		
20	programmatic agreement between the department and the project

applicant that identifies each phase and the estimated timelines
 for each phase.

3 (b) The department shall inform the public of any project
4 proposals submitted to it under this section that are not
5 otherwise subject to the requirement of a public hearing or
6 other public notification.

7 The department shall not commence with review and (C) comment unless the landowner provides the department with 8 project area information and comprehensive identification of 9 10 historic properties, aviation artifacts, or burial sites in an 11 archaeological inventory survey. (d) The department shall not exempt projects on lands 12 13 previously or currently built from an archaeological inventory 14 survey.

15 (e) The department shall compile a list of approved

16 archaeological professionals to ensure the quality and integrity

17 of any archaeological services contracted by developers;

- 19 (1) The department shall consider any qualified
 20 archaeologist that submits a letter of interest and

3	(2)	Each island burial council shall review applicants on
4		an annual basis and may approve or reject an
5		applicant's inclusion on the list of archaeological
6		professionals approved by the department based on the
7		quality of the applicant's previous work.
8	(f)	The information provided in an archaeological
9	inventory	survey involving the identification of historic
10	propertie	s, aviation artifacts, or a burial site on these lands
11	shall con	sider characteristics that indicate the presence of
12	burial si	tes or possible burial sites, pursuant to the
13	definitio	n of "previously identified" under section 13-300-2,
14	Hawaii Ad	ministrative Rules.
15	(g)	Only archaeologists included on the list of
16	archaeolo	gical professionals approved by the department
17	<u>establish</u>	ed in subsection (e) shall conduct professional
18	archaeolo	gical services or administrative archaeological reviews
19	rendered	in the historic preservation process.
20	[(c)] <u>(h)</u> The department shall adopt rules in accordance
21	with chap	ter 91 to implement this section."
