## A BILL FOR AN ACT

RELATING TO EDUCATION.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that the materials or 2 core curricula that districts choose for reading instructions 3 greatly impact student learning and teacher practice. High-4 quality instructional materials are aligned to the science of 5 reading and to the respective state's standards. Investing in 6 and adopting high-quality instructional materials give teachers 7 access to quality content and quality assignments, significantly 8 reducing the need for teachers to search for lower quality and 9 sometimes disconnected assignments online.

10 To ensure the quality and continuity of students' core 11 instructional experiences, the Hawaii department of education 12 has committed to ensuring that all public schools implement a 13 comprehensive instructional program that reflects research based 14 instructional strategies and addresses all or nearly all of the 15 English language arts standards, encompassing phonemic 16 awareness, phonics, fluency, vocabulary, and comprehension.
