BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 92, Hawaii Revised Statutes, is amended 2 by adding a new section to part I to be appropriately designated 3 and to read as follows: 4 Appointment; selection; head of a division or "§92− 5 agency. (a) Upon the vacancy or anticipated vacancy of the 6 head of any division or agency of the State that requires a board to appoint or otherwise select the new head, the board 7 8 shall use open deliberation in an open meeting to establish a 9 process and timeline for the appointment or selection of the new 10 head. Approval of the process and timeline shall be determined 11 in an open meeting. 12 The board shall follow the process and timeline (b) established under subsection (a). If, during the selection 13 14 process, the board determines that the process or timeline 15 requires amendment, the amendment shall be made through open 16 deliberation in an open meeting and approval of the amendment

17 shall be determined in an open meeting.

Public Agency Meetings and Records; Sunshine Law; Open Deliberation; Open Meeting; Appointment; Selection; Head of a State Division or Agency; Voting

Description:

Requires appointments and selections of heads of state divisions and agencies that require a board approval to be made through a publicly established process and timeline. Requires the approval of the process and timeline to appoint or select a new head of a division or agency to be determined in an open meeting. Requires that votes to appoint or select a head of state divisions and agencies to be conducted in an open meeting. Provides that any vote to appoint or select a head of a state division or agency cast in violation of the foregoing shall be invalid. Requires that a vote by a board to appoint or select hire a head of a division or agency be conducted in an open meeting. (SD1)
