### A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that county ordinances
- 2 may prohibit riding a skateboard upon a roadway or street. For
- 3 example, section 15-4.6, Revised Ordinances of the City and
- 4 County of Honolulu, prohibits the riding of a skateboard upon
- 5 any roadway.
- 6 Notwithstanding ordinances prohibiting skateboard use on
- 7 roadways and streets, the legislature further finds that many
- 8 young people ride in violation of the law. The legislature also
- 9 finds that skateboard accidents on roadways and streets usually
- 10 result in serious injury to the rider, particularly head trauma.
- 11 The legislature additionally finds that young people riding
- 12 skateboards on roadways and streets should be required to wear a
- 13 safety helmet.
- 14 The purpose of this Act is to require the use of a safety
- 15 helmet by anyone under the age seventeen while riding a
- 16 skateboard.

- 1 SECTION 2. Chapter 291C, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "§291C- Skateboards; helmet required. (a) No person
- 5 under seventeen years of age shall operate a skateboard upon a
- 6 street, bikeway, or any other public property unless that person
- 7 is wearing a properly fitted and fastened helmet that has been
- 8 tested by a nationally recognized agency such as the National
- 9 Highway Traffic Safety Administration, the National Safety
- 10 Council, or the Children's Safety Network, and is designed to
- 11 fit the user and protect against head trauma.
- 12 (b) This section shall not be construed to legalize the
- 13 use of skateboards in violation of any county ordinance.
- (c) As used in this section:
- 15 "Roadway" shall have the same meaning as defined in section
- **16** 291C-1.
- "Skateboard" means a short board that is on wheels and that
- 18 a person stands on to move along a surface or to perform tricks.
- "Street" shall have the same meaning as defined in section
- **20** 291C-1."
- 21 SECTION 3. New statutory material is underscored.
