A BILL FOR AN ACT

RELATING TO THE OFFICE OF THE PUBLIC DEFENDER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the office of the
- 2 public defender provides necessary legal representation to
- 3 indigent individuals in criminal, involuntary commitment, and
- 4 family law cases as required by the United States and Hawaii
- 5 Constitutions, state statutes, and judicial opinions. The
- 6 legislature further finds that Act 9, Session Laws of
- 7 Hawaii 2020, defunded six positions in the office of the public
- 8 defender, and the positions were later abolished.
- 9 The purpose of this Act is to:
- 10 (1) Fund four deputy public defender III positions; and
- 11 (2) Require the office of the public defender to assign
- one deputy public defender II to the family court
- section.
- 14 SECTION 2. In accordance with section 9 of article VII of
- 15 the Hawaii State Constitution and sections 37-91 and 37-93,
- 16 Hawaii Revised Statutes, the legislature has determined that the
- 17 appropriations contained in Act 164, Regular Session of 2023,

- 1 and this Act will cause the state general fund expenditure
- 2 ceiling for fiscal year 2024-2025 to be exceeded by
- 3 \$ or per cent. This current declaration takes
- 4 into account general fund appropriations authorized for fiscal
- 5 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 6 only. The reasons for exceeding the general fund expenditure
- 7 ceiling are that:
- **8** (1) The appropriation made in this Act is necessary to
- 9 serve the public interest; and
- 10 (2) The appropriation made in this Act meets the needs
- addressed by this Act.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$627,300 or so much
- 14 thereof as may be necessary for fiscal year 2024-2025 for four
- 15 full-time equivalent (4.0 FTE) deputy public defender III
- 16 positions within the office of the public defender (BUF151);
- 17 provided that the office of the public defender shall assign one
- 18 deputy public defender II to the family court section.
- 19 The sum appropriated shall be expended by the office of the
- 20 public defender for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2024.
