A BILL FOR AN ACT

RELATING TO PROCUREMENT PREFERENCES AND RECIPROCITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that supporting Hawaii
- 2 service businesses is an important aspect of the State's
- 3 economy. Hawaii service businesses boost the economy by
- 4 employing Hawaii residents who spend their earnings in the
- 5 State, therefore, when expending public funds, the term "buy
- 6 local" should apply to the State's purchase of services as it
- 7 does to the purchase of goods.
- 8 The legislature further finds that many of the State's
- 9 residents who earn college degrees either leave the State or do
- 10 not return due to the lack of career opportunities. Public
- 11 accounting firms with offices in the State help to address these
- 12 needs by offering professional career paths that allow residents
- 13 to remain in the State. These public accounting firms are
- 14 committed to helping residents develop the professional and
- 15 technical skills necessary to succeed in the public accounting
- 16 industry; however, the high cost of operating a business in
- 17 Hawaii and the high cost of living makes it difficult to compete

- 1 for government contracts with firms without offices in Hawaii
- 2 that operate out of low-cost jurisdictions.
- 3 The legislature further finds that procurement preferences
- 4 can encourage the growth and sustainability of businesses that
- 5 employ Hawaii residents by providing them with a competitive
- 6 advantage in government contracts. This, in turn, can lead to
- 7 the creation of new jobs or the retention of existing ones and
- 8 increase economic activity within the State.
- 9 Accordingly, the purpose of this Act is to:
- 10 (1) Establish a new accounting services procurement
- 11 preference for certain Hawaii accounting service
- businesses; and
- 13 (2) Clarify that the existing reciprocity procurement
- preference includes offerors under section 103D-303,
- 15 Hawaii Revised Statutes.
- 16 SECTION 2. Chapter 103D, Hawaii Revised Statutes, is
- 17 amended by adding a new section to part X to be appropriately
- 18 designated and to read as follows:
- 19 "\$103D- Accounting service businesses. (a) In any
- 20 expenditure of public funds for accounting services, the use of
- 21 Hawaii accounting service businesses shall be preferred. Where

18	SECT	ION 3. Section 103D-1001, Hawaii Revised Statutes, is
19	amended by adding three new definitions to be appropriately	
20	inserted and to read as follows:	

1 ""Accounting services" means the art of recording, 2 classifying, and summarizing, in a significant manner and in 3 terms of money, transactions and events that are, at least in 4 part, of a financial character, and interpreting the results. 5 "Accounting services" shall include assurance services, such as 6 the performance of an audit. 7 "Commercial place of business" means a physical location in the State, such as an office, suite, unit, where business is 8 9 regularly conducted. A "commercial place of business" shall not 10 include a dwelling or any physical location in which a person resides or a physical location being used for business purposes 11 12 in violation of the applicable land use or zoning laws. 13 "Hawaii accounting service business" means any person, 14 agency, corporation, or other business entity engaged in the 15 business of accounting services with a commercial place of 16 business located in the State." 17 SECTION 4. Section 103D-1004, Hawaii Revised Statutes, is 18 amended by amending subsection (a) to read as follows: 19 "(a) To ensure fair and open competition for Hawaii 20 businesses engaged in contracting with other states, the chief 21 procurement officer may impose a reciprocal preference against

- 1 bidders and offerors pursuant to sections 103D-302 and 103D-303
- 2 from those states which apply preferences. The amount of the
- 3 reciprocal preference shall be equal to the amount by which the
- 4 non-resident preference exceeds any preference applied by this
- 5 State.
- 6 In determining whether a bidder or offeror qualifies as a
- 7 resident bidder $[\tau]$ or offeror, the definition used by the other
- 8 state in applying a preference shall apply."
- 9 SECTION 5. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 6. This Act shall take effect upon its approval.
