## A BILL FOR AN ACT

RELATING TO BURIAL SITES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to impose a fine of
2	\$1,000 on any private landowner who fails to disclose and record
3	the existence of burial or archaeological sites on their
4	property that the landowner knew or should have known of.
5	SECTION 2. Chapter 508D, Hawaii Revised Statutes, is
6	amended by adding a new section to be appropriately designated
7	and to read as follows:






1 SECTION 3. Section 6E-16, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 2 3 There [is] shall be established a Hawaii historic "(a) preservation special fund into which shall be deposited the 4 5 following moneys: Appropriations by the legislature to the special fund; 6 (1)Gifts, donations, and grants from public agencies and 7 (2) 8 private persons; All proceeds collected by the department derived from 9 (3) historic preserve user fees, historic preserve leases 10 or concession fees, fees charged to carry out the 11 12 purposes of this chapter, or the sale of goods; [and] 13 Civil, criminal, and administrative penalties, fines, (4) 14 and other charges collected under this chapter or any 15 rule adopted pursuant to this chapter [-]; and Fines collected under section 508D- . 16 (5) All interest earned or accrued on moneys deposited in the fund 17 18 shall become part of the fund. The fund shall be administered 19 by the department; provided that the department may contract 20 with a public or private agency to provide the day-to-day 21 management of the fund."

Bureau of Conveyances; Burial Sites; Private Property; Landowners

## Description:

Imposes a fine on any private landowner that fails to disclose or record with the Bureau of Conveyances, or in documents used to offer real property for sale, the existence of burial or archaeological sites on their property that the landowner knew or should have known of. Requires fines collected to be deposited into the Hawaii Historic Preservation Special Fund. (CD1)
