A BILL FOR AN ACT

RELATING TO CAREER AND TECHNICAL EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has an 2 obligation to prepare its students with the tools necessary for 3 successful futures in the modern economy. In 2017, seventeen per cent of the State's high school students did not graduate. 4 5 Further, only fifty-five per cent of the State's high school 6 students eventually enroll in post-secondary education after high school, with only thirty-two per cent enrolling in a 7 8 four-year university. Accordingly, the legislature believes 9 that it is the department of education's responsibility to 10 provide students with additional career options that do not 11 require bachelor's degrees.

12 The legislature also finds that a traditional four-year 13 bachelor's degree is becoming increasingly irrelevant for 14 earning potential and job placement, especially in regards to 15 the debt-to-income ratio incurred by many students at private 16 colleges and universities. The legislature further finds that 17 more than forty-four million borrowers currently owe a total of

1 \$1,500,000,000,000 in student loan debt, with the average 2 college graduate owing \$37,172 in student loans in 2016. The 3 legislature notes that nationwide, three out of ten high school 4 graduates from four-year public universities have not earned 5 degrees within six years. Further, a bachelor's degree is no 6 longer the sole path to economic self-sufficiency that it once 7 was. Many well-paying jobs do not require any level of higher 8 education, as evidenced by the nearly thirty million jobs in the 9 United States that pay an average of \$55,000 per year without 10 requiring a bachelor's degree.

11 The legislature recognizes that trade jobs are a growing 12 area of opportunity for high school graduates. According to the United States Department of Labor, there were 6,600,000 trade 13 14 job openings in early 2018, with the number of openings expected 15 to outpace the number of available employees in the near future. Moreover, the United States Department of Education reports that 16 17 there will soon be sixty-eight per cent more job openings in 18 infrastructure-related fields than there are people trained to 19 fill them. Some states already have more job vacancies than 20 qualified workers for certain trade jobs, including but not 21 limited to carpentry, electrical, plumbing, sheet-metal work,

and pipe-fitting. Additionally, the United States Bureau of
Labor Statistics projects that by 2031, the construction,
healthcare support, and personal care and service sectors will
grow by a combined 24.4 per cent.

5 The legislature notes that many high school graduates are currently benefitting from trade jobs. For some industries, a 6 7 technical program graduate can earn an income that is above the national average, plus benefits, after just a few semesters of 8 9 certificate training that costs just a fraction of a comparable 10 undergraduate education. The legislature also notes that the 11 tuition and fees for community or technical colleges are also significantly cheaper than four-year universities. 12

The legislature also believes that encouraging vocational 13 14 training in department of education schools and providing additional resources to these programs will benefit those 15 students for whom a four-year university is not the right 16 choice. The legislature further believes that the State must 17 help its students take advantage of a historically strong 18 19 national economy by preparing them for family wage jobs that do not require a bachelor's degree. 20

Accordingly, the purpose of this Act is to:

1 Require the department of education to hire (1) individuals to teach vocational, technical, or career 2 3 pathway classes; and 4 (2) Authorize department of education teachers to instruct 5 vocation, technical, or career pathway classes without possessing an applicable bachelor's degree. 6 7 SECTION 2. Section 302A-602, Hawaii Revised Statutes, is 8 amended to read as follows: 9 "§302A-602 Teachers; licenses and certificates. (a) No 10 person shall serve as a teacher in the department without first having obtained a license from the Hawaii teacher standards 11 12 board in [such] a form as the Hawaii teacher standards board 13 determines. The department shall establish types of 14 certificates in the educational field and the requirements to qualify for those certificates issued to individuals who are not 15 16 required to obtain a license pursuant to sections 302A-801 to 17 302A-808. 18 Beginning with the 2002-2003 school year, no person (b) 19 paid under the salary schedule contained in the unit 5 20 collective bargaining agreement shall serve as a teacher in the 21 department without first having obtained a license pursuant to

4	(c) Beginning with the 2002-2003 school year, the

13	chapters 91 and 92, to initiate the following:
14	(1) Develop criteria allowing more individuals with trade
15	or industry experience to teach in vocational,
16	technical, and career pathway programs, and criteria
17	for the issuance of permits allowing qualified
18	individuals to teach when recommended by the
19	superintendent or the commission, when appropriate.
20	The department or the commission, when appropriate,
21	shall be responsible for the review and acceptance of

1		the relevant licenses, certificates, or other
2		qualifications related to an individual's vocational,
3		technical, or career pathway education-related
4		experience that the department or the commission, when
5		appropriate, deems necessary for a permit. The
6		department or the commission [, when appropriate,]
7		shall [have the authority to] waive the requirement of
8		a bachelor's degree to teach in a vocation, technical,
9		or career pathway education program;
10	(2)	Develop a plan to accept teachers from any state as
11		long as they have completed state-approved teacher
12		education programs and pass relevant Hawaii teacher
13		examinations or their equivalent;
14	(3)	Clarify the requirements, on a state-by-state basis,
15		for out-of-state licensed teachers to obtain a license
16		in Hawaii;
17	(4)	Develop a plan to facilitate licensing for those who
18		intend to teach in Hawaii immersion programs, the
19		island of Niihau, or any other extraordinary situation
20		as defined by the superintendent or the

1	violates this subpart by employing an individual as a public
2	school teacher who does not possess a valid license or is not a
3	department of education or charter school emergency hire as
4	defined in this chapter; or is not hired as a vocational,
5	technical, or career pathway teacher pursuant to section
6	302A-801(d), may be fined not more than \$500. All fines shall
7	be deposited into the general fund."
8	SECTION 6. This Act does not affect rights and duties that
9	matured, penalties that were incurred, and proceedings that were
10	begun before its effective date.
11	SECTION 7. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 8. This Act shall take effect on July 1, 2023.
