### A BILL FOR AN ACT

RELATING TO ARREST PHOTOGRAPHS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that booking or arrest
- photographs, also called mugshots, can be obtained from law 2
- 3 enforcement websites and reposted on commercial websites.
- some websites will usually remove the photographs without 4
- 5 charging a fee if the charges were dropped or the person was
- found to be not guilty, other websites charge a fee for their 6
- The legislature also finds that once posted on the 7
- 8 Internet, the photographs can be copied and shared by other
- sites and are extremely difficult to eradicate. 9
- 10 The legislature further finds that a number of states have
- 11 laws prohibiting the use of booking or arrest photographs for
- 12 commercial purposes or prohibiting the websites from charging
- fees or gaining revenue related to the photographs. 13
- 14 legislature also notes that several credit card companies have
- 15 reportedly cut ties with mugshot websites and a search engine
- 16 has changed its algorithms so that the websites do not result as
- 17 often.



1 Accordingly, the purpose of this Act is to prohibit 2 commercial website operators from publishing mugshots. 3 SECTION 2. Chapter 481B, Hawaii Revised Statutes, is amended by adding a new section to part I to be appropriately 4 5 designated and to read as follows: 6 "§481B- Restrictions on publication of mugshots on a 7 commercial website. (a) A mugshot website operator who 8 publishes mugshots for a commercial purpose on a publicly 9 accessible website shall be deemed to be transacting business in 10 the State. 11 (b) A mugshot website operator shall not use a mugshot for 12 the purpose of soliciting business for pecuniary gain, including 13 requiring the payment of a fee or other valuable consideration 14 in exchange for removing a mugshot that has been published on a 15 website or other publication. 16 (c) An individual whose mugshot is published in violation 17 of subsection (b) and who suffers a pecuniary loss or is 18 otherwise adversely affected as a result of the violation shall 19 have a cause of action against the person responsible for the 20 violation and may recover damages in addition to the damages

1	prescribed in subsection (d) in any court of competent							
2	jurisdict	ion.						
3	<u>(d)</u>	A person who violates subsection (b) shall be liable						
4	for damages for each separate violation in an amount of at							
5	<u>least:</u>							
6	(1)	\$100 per day during the first thirty days of the						
7		violation;						
8	(2)	\$200 per day during the subsequent thirty days of the						
9		violation; and						
10	(3) \$500 per day for each day thereafter.							
11	(e) This section shall not apply to:							
12	(1) Any act performed for the purpose of disseminating							
13	news to the public, including the gathering,							
14	publishing, or broadcasting of information to the							
15	public for a news-related purpose, or to any act							
16	performed by a publisher, owner, agent, employee,							
17		retailer of a newspaper, radio network, television						
18		station, television broadcast network, cable						
19		television network, or other online news outlet						
20		associated with any news organization in connection						
21		with the dissemination of news to the public,						

1		including the gathering, publishing, or broadcasting					
2	of information to the public for a news-related						
3	purpose;						
4	4 (2) Activities by a licensed attorney, private  investigator, or registered process server that a						
5							
6		associated with purposes relating to a current or					
7		anticipated criminal or civil proceeding; or					
8	(3)	The conduct of trials or the discovery process in any					
9		proceeding as otherwise provided by law or court rule.					
10	<u>(f)</u>	For the purposes of this section:					
11	"Mugshot" means a photograph of an individual's face that						
12	is taken	pursuant to an arrest or other involvement in the					
13	criminal justice system.						
14	"Mug	shot website operator" means a person that publishes					
15	mugshots on a publicly available internet website for a						
16	commercial purpose.						
17	"Person" includes an individual, partnership, firm,						
18	association, corporation, or other legal entity."						
19	SECTION 3. This Act does not affect rights and duties that						
20	matured,	penalties that were incurred, and proceedings that were					
21	begun bef	ore its effective date.
