### A BILL FOR AN ACT

RELATING TO CIVIC ENGAGEMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that civic engagement is
- 2 critical for a functioning democracy in the State. However, the
- 3 State experiences one of the lowest rates of civic engagement,
- 4 including voting, in the United States. Additionally, the State
- 5 prohibits students under the age of eighteen from voting,
- 6 serving in elected office, or other civic engagement activities
- 7 and opportunities afforded to adults. Engaging students in
- 8 neighborhood boards or regional community advisory boards
- 9 provides young adults with new ways to engage their communities
- 10 and ensure the issues relevant to the State's next generation
- 11 are considered in community decision-making.
- 12 Accordingly, to increase and assure effective citizen
- 13 participation in the decisions of government, the purpose of
- 14 this Act is to:
- 15 (1) Authorize each public high school in the State to
- 16 select not more than two students to serve on a
- neighborhood board or regional community advisory

4	(2) Allow the students selected to participate to serve as
5	voting members of the neighborhood boards.
6	SECTION 2. Chapter 92, Hawaii Revised Statutes, is amended
7	by adding a new section to part VII to be appropriately
8	designated and to read as follows:
9	"§92- Neighborhood boards; regional community advisory
10	boards; student members; selection. (a) Notwithstanding any
11	other law to the contrary, each public high school in any county
12	with an established neighborhood board or regional community
13	advisory board may select not more than two students to
14	represent the interests of students at the public high school
15	and young people in the community. The selected students may
16	participate in neighborhood board or regional community advisory
17	board activities representing the complex area where the public
18	high school is located.
19	(b) Students selected to serve on a neighborhood board or
20	regional community advisory board shall be voting members;
21	provided that student members shall not increase or change the

- 1 threshold for quorum on the board on which they serve; provided
- 2 further that students may be counted toward existing quorum for
- 3 board matters pursuant to section 92-81(d).
- 4 (c) Students selected to serve on a neighborhood board or
- 5 regional community advisory board shall commence their term at
- 6 the first scheduled board meeting following their selection
- 7 until a replacement student member is selected."
- 8 SECTION 3. New statutory material is underscored.
- 9 SECTION 4. This Act shall take effect upon its approval.

#### Report Title:

Department of Education; Neighborhood Boards; Regional Community Advisory Boards; Student Representation; Membership; Selection; Quorum; Voting; Permitted Activities; Terms

### Description:

Requires all public high schools statewide to select not more than two students to represent the interests of students at the public high school and young people in the community on the neighborhood board or regional community advisory board where the public high school is located, if any. Authorizes students to serve as voting members. Provides that students may contribute to existing quorum. Establishes terms for selected students.
