### A BILL FOR AN ACT

RELATING TO INCOME.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. The legislature finds that the tip credit
 authorized by section 387-2, Hawaii Revised Statutes, allows
 employers to pay certain employees at a rate below the state
 minimum wage by calculating tips as a portion of the employee's
 wages.

6 The purpose of this Act is to increase the income of tipped 7 workers by gradually phasing out the tip credit so that all 8 employers shall be required to pay all employees at least the 9 minimum wage.

SECTION 2. Section 387-2, Hawaii Revised Statutes, is
amended by amending subsection (b) to read as follows:

12 "(b) The hourly wage of a tipped employee may be deemed to 13 be increased on account of tips if the employee is paid not less 14 than:

15 (1) 25 cents;

16 (2) 50 cents per hour beginning January 1, 2015;

17 (3) 75 cents per hour beginning January 1, 2016;
