A BILL FOR AN ACT

RELATING TO NOISE POLLUTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that noise pollution is a
- 2 serious problem affecting quality of life, particularly in urban
- 3 areas. Internal combustion engine mopeds with factory mufflers
- 4 are often many times louder than larger motorcycles that have
- 5 greater engine displacement and robust exhaust baffles, and they
- 6 continue to be a cause for concern in communities throughout the
- 7 State.
- 8 The legislature further finds that internal combustion
- 9 engine mopeds are significant contributors to noise pollution,
- 10 often having higher noise levels than vehicles and detrimentally
- 11 affecting communities. Internal combustion engine mopeds can be
- 12 up to twenty decibels louder than electric mopeds.
- 13 Additionally, the broad deployment of charging infrastructure is
- 14 not an impediment to the adoption of electric mopeds because
- 15 electric moped batteries can be easily removed and charged
- 16 inside a residence or workplace.

- 1 The purpose of this Act is to prohibit retailers from
- 2 selling or offering for sale any combustion engine-powered moped
- 3 unless the moped was initially purchased in a consumer
- 4 transaction before January 1, 2026.
- 5 SECTION 2. Chapter 286, Hawaii Revised Statutes, is
- 6 amended by adding a new section to part I to be appropriately
- 7 designated and to read as follows:
- 8 "S286- Sale of certain combustion engine-powered mopeds
- 9 prohibited; penalties. (a) Beginning January 1, 2026, no
- 10 retailer shall sell or offer for sale any combustion engine-
- 11 powered moped that the retailer initially purchased after
- 12 December 31, 2025.
- 13 (b) This section shall not be construed to prohibit any
- 14 individual or retailer from reselling, renting, or offering for
- 15 resale or rent a combustion engine-powered moped that was
- 16 initially purchased in a consumer transaction before January 1,
- **17** 2026.
- 18 (c) Any person who violates this section shall be fined no
- 19 more than \$1,000 for each separate offense. Each moped sold or
- 20 offered for sale in violation of this section shall constitute a
- 21 separate offense.

2	person or entity that engages in the business of selling mopeds
3	to consumers."
4	SECTION 3. New statutory material is underscored.
5	SECTION 4. This Act shall take effect upon its approval.
