### A BILL FOR AN ACT

RELATING TO THE EWA BEACH PUBLIC AND SCHOOL LIBRARY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that on August 28, 1971, 2 the Ewa Beach public and school library opened on the James 3 Campbell high school campus with the dual purpose of serving as 4 both a school library and a community library. The Ewa Beach 5 public and school library is administratively established within 6 the Hawaii public library system and the hours are established by the state librarian, subject to state library funding. 7 8 The legislature further finds that the operational hours of 9 the Ewa Beach public and school library make it difficult for 10 the students of James Campbell high school and the nearby Pohakea elementary school and Ilima Intermediate school to use 11 12 the library. The library is currently open on Mondays and Tuesdays from 12:00 p.m. to 4:00 p.m. and 5:00 p.m. to 7:00 13 p.m., Wednesdays and Thursdays from 9:00 a.m. to 1:00 p.m. and 14 2:00 p.m. to 4:00 p.m., Fridays from 12:00 p.m. to 4:00 p.m., 15 16 and is closed on Saturdays and Sundays.

The purpose of this Act is to require the department of
 education to transfer the Ewa Beach public and school library
 from the state public library system to James Campbell high
 school.

5 SECTION 2. The department of education shall transfer the
6 Ewa Beach public and school library, located at 91-950 North
7 Road, Ewa Beach, Hawaii 96706, from the state public library
8 system to James Campbell high school.

9 SECTION 3. All rights, powers, functions, and duties of 10 the state public library system with regard to Ewa Beach public 11 and school library are transferred within the department of 12 education.

13 All employees who occupy civil service positions and whose 14 functions are transferred within the department of education by this Act shall retain their civil service status, whether 15 16 permanent or temporary. Employees shall be transferred without 17 loss of salary, seniority (except as prescribed by applicable 18 collective bargaining agreements), retention points, prior 19 service credit, any vacation and sick leave credits previously 20 earned, and other rights, benefits, and privileges, in 21 accordance with state personnel laws and this Act; provided that

1 the employees possess the minimum qualifications and public
2 employment requirements for the class or position to which
3 transferred or appointed, as applicable; provided further that
4 subsequent changes in status may be made pursuant to applicable
5 civil service and compensation laws.

Any employee who, prior to this Act, is exempt from civil 6 7 service and is transferred as a consequence of this Act may 8 retain the employee's exempt status, but shall not be appointed 9 to a civil service position as a consequence of this Act. An 10 exempt employee who is transferred by this Act shall not suffer any loss of prior service credit, vacation or sick leave credits 11 previously earned, or other employee benefits or privileges as a 12 13 consequence of this Act; provided that the employees possess 14 legal and public employment requirements for the position to which transferred or appointed, as applicable; provided further 15 16 that subsequent changes in status may be made pursuant to 17 applicable employment and compensation laws. The superintendent 18 of education may prescribe the duties and qualifications of 19 these employees and fix their salaries without regard to chapter 20 76, Hawaii Revised Statutes.

1 SECTION 4. All appropriations, records, equipment, 2 machines, files, supplies, contracts, books, papers, documents, 3 maps, and other personal property heretofore made, used, 4 acquired, or held by the state public library system regarding 5 the Ewa Beach public and school library and transferred within 6 the department of education shall be transferred with the 7 functions to which they relate. 8 SECTION 5. This Act shall take effect upon its approval.
