### A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE TWENTIETH SENATORIAL DISTRICT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The twentieth senatorial district encompasses
- 2 Ewa Beach, Ocean Pointe, Ewa By Gentry, Iroquois Point, and a
- 3 portion of Ewa Villages.
- 4 The purpose of this Act is to appropriate funds for capital
- 5 improvement projects in the twentieth senatorial district.
- 6 SECTION 2. The director of finance is authorized to issue
- 7 general obligation bonds in the sum of \$105,920,000 or so much
- 8 thereof as may be necessary and the same sum or so much thereof
- 9 as may be necessary is appropriated for fiscal year 2023-2024
- 10 for the purpose of financing capital improvement projects for
- 11 the twentieth senatorial district, as follows:
- 12 1. To be expended by the department of transportation:
- 13 Fort Weaver road, Oahu
- 14 Construction related to road
- improvements and extension of
- 16 Keaunui drive to Renton road.
