A BILL FOR AN ACT

RELATING TO DIRECT INSTRUCTIONAL SERVICES TO STUDENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that despite unmet 2 resource needs at the school level, the board of education 3 recently approved, without approval or a specific appropriation 4 from the legislature, the creation of two new deputy superintendent positions with salaries of \$190,000 each. 5 6 Including expenses for fringe benefits, those two positions will cost the department of education more than \$579,000 per year. 7 It is expected that school level services will be reduced to 8 9 fund those costs, which has concerned many individuals.

10 The legislature believes that funds allocated to the 11 schools and programs that provide instructional services 12 directly to students should not be reduced to fund the 13 department's administration and that those schools and programs 14 should be allowed to carry over a portion of their allocated 15 funds to the next year.

16 Accordingly, the purpose of this Act is to increase direct17 support to students by requiring that certain allocated funds

2	of education with flexibility to hire temporary employees for	
3	student instructional services.	
4	SECTION 2. Section 302A-1116, Hawaii Revised Statutes, is	
5	amended to read as follows:	
6	"[[]§302A-1116[]] Authority to create temporary positions.	
7	The department may create temporary positions as it deems	
8	necessary; provided that:	
9	(1)	The department's expenditures shall not exceed its
10		allocated budget;
11	(2)	The term of each position shall not exceed one year;
12		[and]
13	(3)	The temporary position is created to provide
14		instructional services directly to students; and
15	(4)	The department shall report the creation of temporary
16		positions to the department of budget and finance $[\cdot,]$
17		and the legislature."
