### A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that genocide is defined
- 2 as "the deliberate killing of a large number of people from a
- 3 particular nation or ethnic group, with the aim at destroying
- 4 that nation or group." Instances of past genocides include the
- 5 Holocaust, the largest blatant genocide, the Armenian Genocide,
- 6 the Famine-Genocide in Ukraine, the Rwandan Genocide, and
- 7 atrocities in Cambodia, Bosnia, Sudan, and Darfur.
- 8 The legislature further finds that as the number of living
- 9 Holocaust survivors and eyewitnesses dwindles, Holocaust denial
- 10 and ignorance are becoming much more prevalent. It is important
- 11 that stories of survivors of the Holocaust be told to audiences
- 12 around the globe. Unfortunately, far too many students in the
- 13 United States grow up without basic knowledge of the events of
- 14 the Holocaust.
- 15 The legislature additionally finds that there are alarming
- 16 lapses in knowledge about the Holocaust throughout the country.
- 17 A survey released in April 2018 by the Conference on Jewish



- 1 Material Claims Against Germany shows that Americans are
- 2 forgetting about the Holocaust or are completely unaware it
- 3 occurred. For instance, while there were over forty thousand
- 4 camps and ghettos during the Holocaust, forty-nine per cent of
- 5 millennials (people born between 1981 and 1996) cannot name one
- 6 of these camps or ghettos. Thirty-one per cent of Americans
- 7 believe that two million or fewer Jews were killed in the
- 8 Holocaust, even though six million Jews and millions of others
- 9 perished.
- 10 In order to bridge the gap between the facts of history and
- 11 what people know, it is imperative that comprehensive Holocaust
- 12 education is taking place in every secondary school across the
- 13 country. Accordingly, the purpose of this Act is to require the
- 14 department of education to develop and implement a Holocaust and
- 15 genocide curricula.
- 16 The legislature intends that through this Act, students are
- 17 educated on the historical existence of the Holocaust, one of
- 18 the most devastating genocides in historical documentation, and
- 19 other documented genocides. The legislature further intends
- 20 that the curriculum developed pursuant to this Act will teach
- 21 the difference between genocide, conducted through killing and

Ţ	eradication	of a group, and cultural genocide, conducted through	
2	the dismantling of a people's identity.		
3	SECTION	2. Chapter 302A, Hawaii Revised Statutes, is	
4	amended by a	dding a new section to be appropriately designated	
5	and to read	as follows:	
6	" <u>§302A</u> -	Holocaust and genocide; curricula plan; public	
7	schools. (a	) The department shall develop and, beginning with	
8	the 2024-202	5 school year, implement a statewide Holocaust and	
9	genocide cur	ricula plan for public school students in a grade	
10	and age appr	opriate manner, which shall be implemented within	
11	social studi	es and language arts courses of study.	
12	(b) A	minimum of six hours of instruction of the Holocaust	
13	and genocide	curricula between grades eight through twelve shall	
14	be required for each student prior to graduation from high		
15	school.		
16	(c) Th	e Holocaust and genocide curricula shall include, at	
17	minimum:		
18	<u>(1)</u> <u>An</u>	additional unit of instruction studying acts of	
19	ge	nocide across the globe, including but not limited	
20	to	the Holocaust, Armenian Genocide, the Famine-	

1		Genocide in Ukraine, the Rwandan Genocide, and
2		atrocities in Cambodia, Bosnia, Sudan, and Darfur;
3	(2)	The breadth of the history of the Holocaust, including
4		information on the Third Reich dictatorship; events of
5		the Nazi atrocities of 1933 to 1945, including but not
6		limited to the concentration camp system and
7		persecution of Jews and non-Jews; Jewish and
8		non-Jewish resistance; and post-World War II trials;
9	<u>(3)</u>	A discussion of antisemitism, racism, and the
10		abridgement of civil rights by Nazi Germany and its
11		collaborators;
12	(4)	Instruction that communicates the connection between
13		nation, ethnic, racial, or religious intolerance, the
14		Holocaust, and the impact of personal responsibility,
15		civic engagement, and societal response within the
16		context of the Holocaust; and
17	(5)	Acknowledgement of genocides occurring within a
18		society previously considered an advance society,
19		including scientifically demonstrated steps toward
20		genocide and warning signs of genocide.

1	(d) The Holocaust and genocide curricula shall be taught
2	in a manner that leads to an investigation of human behavior; an
3	understanding of the ramifications of antisemitism leading to
4	prejudice, racism, and stereotyping; and an examination of what
5	it means to be a responsible and respectful person.
6	(e) The department shall establish curriculum guidelines
7	and distribute information about appropriate curriculum
8	materials to each public school and make available in-service
9	training programs based upon instruction provided for and the
10	curriculum guidelines established pursuant to this section.
11	(f) The department shall create and distribute materials
12	and resources to respond to antisemitism, racism, and
13	hate-related topics for teachers to use when either the teacher
14	or a student faces, experiences, or is exposed to antisemitism,
15	racism, or crimes of hate by another student, teacher, parents
16	or guardians of a student, or a guest of a school.
17	(g) Public schools may utilize:
18	(1) Any curriculum that complies with the requirements of
19	this section;

1	(2)	Programs made available by the department or from
2		alternative sources if they are deemed consistent with
3		this section; and
4	(3)	Any appropriate public or private materials,
5		personnel, and other resources in developing and
6		implementing the program of instruction.
7	<u>(h)</u>	The department shall work in consultation with
8	organizat	ions and individuals that provide educational expertise
9	and resou	rces related to the Holocaust, genocide, and human
10	rights vi	olations to develop the curriculum guidelines.
11	<u>(i)</u>	The department may accept gifts, grants, and
12	donations	, including in-kind donations, from public agencies and
13	private p	ersons to be designated for the development and
14	implement	ation of the Holocaust and genocide curricula required
15	pursuant	to this section.
16	<u>(j)</u>	For the purposes of this section:
17	"Gen	ocide" includes any of the following acts committed
18	with inte	nt to destroy, in whole or in part, a national, ethnic,
19	racial, c	r religious group:
20	(1)	Killing members of the group;

1	(2)	Causing serious bodily or mental harm to members of
2		the group;
3	(3)	Deliberately inflicting on the group conditions of
4		life calculated to bring about its physical
5		destruction in whole or in part;
6	(4)	Imposing measures intended to prevent births within
7		the group; or
8	(5)	Forcibly transferring children of the group to another
9		group.
10	"Holocaust" means the systematic, state-sponsored,	
11	persecuti	on and murder of six million Jews and the targeting of
12	other gro	ups including Roma and Sinti, political dissidents, gay
13	men, Slav	ic peoples, and other individuals deemed inferior by
14	the Nazi regime and its collaborators."	
15	SECTION 3. The department of education shall submit a	
16	report on the progress of developing and implementing the	
17	statewide Holocaust and genocide curricula plan pursuant to	
18	section 2	of this Act including any findings, recommendations,
19	and propo	sed legislation, to the legislature no later than
20	twenty days prior to the convening of the regular session of	
21	2025.	

1 SECTION 4. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 2 much thereof as may be necessary for fiscal year 2024-2025 for 3 the development and implementation of the Holocaust and genocide 4 5 curricula required pursuant to section 302A- , Hawaii Revised 6 Statutes. 7 The sum appropriated shall be expended by the department of education for the purposes of this Act. 8 9 SECTION 5. In accordance with section 9 of article VII of the Hawaii State Constitution and sections 37-91 and 37-93, 10 Hawaii Revised Statutes, the legislature has determined that the 11 appropriations contained in H.B. No. , will cause the state **12** general fund expenditure ceiling for fiscal year 2024-2025 to be 13 14 exceeded by \$ per cent. In addition, the or appropriation contained in this Act will cause the general fund 15 16 expenditure ceiling for fiscal year 2024-2025 to be further 17 exceeded by \$ per cent. The combined total or amount of general fund appropriations contained in only these 18 19 two Acts will cause the state general fund expenditure ceiling 20 for fiscal year 2024-2025 to be exceeded by

1	\$ or per cent. The reasons for exceeding the
2	general fund expenditure ceiling are that:
3	(1) The appropriation made in this Act is necessary to
4	serve the public interest; and
5	(2) The appropriation made in this Act meets the needs
6	addressed by this Act.
7	SECTION 6. New statutory material is underscored.
8	SECTION 7. This Act shall take effect upon its approval;
9	provided that section 4 shall take effect on July 1, 2024.
