A BILL FOR AN ACT

RELATING TO EXCLUSIVE LISTING AGREEMENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act shall be known, and may be cited, as
 the Exclusive Listing Agreements Act.

3 SECTION 2. The legislature finds that long-term exclusive
4 listing agreements, and the recording of exclusive listing
5 agreements, unfairly encumbers a property owner's title, reduces
6 their equity, and has an anti-competitive effect on the sale of
7 real estate.

8 Accordingly, the purpose of this Act is to:

9 (1) Prohibit exclusive listing agreements for the sale of
10 real estate, including agreements to enter into any
11 such agreement or arrangement, lasting longer than
12 twelve months; and

13 (2) Prohibit the recording of exclusive listing agreements
14 of any duration for the sale of real estate, including
15 agreements to enter into the agreement or arrangement.

1	SECTION 3. Chapter 481B, Hawaii Revised Statutes, is
2	amended by adding a new section to part I to be appropriately
3	designated and to read as follows:
4	"§481B- Exclusive listing agreements; prohibited. (a)
5	It is unlawful for an exclusive listing agreement to last longer
6	than twelve months from the date the agreement was made.
7	(b) It is unlawful to present for recording or filing, or
8	otherwise attempt to record to file, with the bureau of
9	conveyances an exclusive listing agreement of any duration or
10	any memoranda or notice of an exclusive listing agreement.
11	(c) It is unlawful to enforce, or attempt to enforce, an
12	exclusive listing agreement that is made, or that is presented
13	for recording or filing with the bureau of conveyances, in
14	violation of this section.
15	(d) An exclusive listing agreement that is made or that is
16	presented for recording or filing with the bureau of conveyances
17	in violation of this section shall be void and unenforceable.
18	An owner who entered into an exclusive listing agreement may
19	retain any consideration received thereunder.
20	(e) A violation of this section shall be deemed an unfair
21	or deceptive practice in accordance with section 480-2, and

1	shall be subject to the provisions of chapter 480, as well as
2	the provisions of this chapter.
3	(f) For the purposes of this section, "exclusive listing
4	agreement" means a contract or agreement providing an exclusive
5	right to list or sell real estate, including a contract or
6	agreement to enter into an agreement or arrangement."
7	SECTION 4. Chapter 502, Hawaii Revised Statutes, is
8	amended by adding a new section to part IV be appropriately
9	designated and to read as follows:
10	" <u>\$502-</u> Exclusive listing agreements; prohibited. (a)
11	It is unlawful to present for recording or filing, or otherwise
12	attempt to record or file, with the bureau of conveyances an
13	exclusive listing agreement of any duration or any memoranda or
14	notice of such agreement. A violation of this section shall be
15	deemed a violation of section 481B
16	(b) For the purpose of this section, "exclusive listing
17	agreement" has the same meaning as provided in section 481B"
18	SECTION 5. New statutory material is underscored.
19	SECTION 6. This Act shall take effect upon its approval.
