### A BILL FOR AN ACT

RELATING TO DIRECT INSTRUCTIONAL SERVICES TO STUDENTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that despite unmet
- 2 resource needs at the school level, the board of education
- 3 recently approved, without approval or a specific appropriation
- 4 from the legislature, two new deputy superintendents with
- 5 salaries of \$190,000 each. Including expenses for fringe
- 6 benefits, those two positions will cost the department of
- 7 education more than \$579,000 per year. It is expected that
- 8 school level services will be reduced to fund those costs, which
- 9 has concerned many individuals.
- 10 The legislature believes that funds allocated to the
- 11 schools and programs that provide instructional services
- 12 directly to students should not be reduced to fund the
- department's administration and that those schools and programs
- 14 should be allowed to carry over a portion of their allocated
- 15 funds to the next year.
- 16 The purpose of this Act is to increase direct support to
- 17 students by requiring that certain allocated funds remain with

- 1 the school or program and providing the department of education
- 2 with flexibility to hire temporary employees for student
- 3 instructional services.
- 4 SECTION 2. Section 37-41.5, Hawaii Revised Statutes, is
- 5 amended by amending subsection (b) to read as follows:
- 6 "(b) Appropriations allocated to the schools or to
- 7 programs that provide instructional services directly to
- 8 students shall remain within the budget of the school or program
- 9 to which they were originally allocated; provided that the
- 10 retention of an appropriation shall not be used by the
- 11 department as a basis for reducing a school's or program's
- 12 future budget requirements."
- SECTION 3. Section 302A-1116, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- "[+]\$302A-1116[+] Authority to create temporary positions.
- 16 The department may create temporary positions as it deems
- 17 necessary; provided that:
- 18 (1) The department's expenditures shall not exceed its
- 19 allocated budget;
- 20 (2) The term of each position shall not exceed one year;

### Report Title:

DOE; Funds Carryover; Budgeting; Temporary Positions; Legislature; Reporting Requirement

#### Description:

Requires that appropriations allocated to Department of Education programs that provide instructional services directly to students shall remain within the budget of the program to which they were originally allocated and that the retention of an appropriation shall not be used by the department as a basis for reducing a program's future budget requirements. Allows the Department of Education to create temporary positions under certain conditions. Amends the requirement that the Department of Education report the creation of temporary positions to the Department of Budget and Finance by requiring that the report also be sent to the Legislature.
