## A BILL FOR AN ACT

RELATING TO MINIMUM WAGE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's cost of 2 living continues to be burdensome for the State's residents. 3 According to the National Low Income Housing Coalition's "Out of 4 Reach 2023" report, a minimum wage employee must work one 5 hundred seven hours per week to afford a one-bedroom rental home 6 at fair market prices. To afford a two-bedroom residence 7 without being cost burdened, the National Low Income Housing 8 Coalition estimates that a person must earn \$41.83 per hour. 9 The State's electricity prices are also the highest in the 10 nation, while cost of other essential items, like food and 11 clothing, have risen significantly in recent years.

12 The legislature further finds that Act 114, Session Laws of 13 Hawaii 2022, gradually increases Hawaii's minimum wage to \$18 14 per hour by 2028. However, the Massachusetts Institute of 15 Technology's living wage calculator estimates that in 2023, a 16 livable wage in the State for a single adult with no children

was \$22.05 per hour, and was \$43.75 per hour for a single adult
 with one child.

The legislature additionally finds that the December 2023 3 report "The High Cost of Low Wages" published by the Hawaii 4 Appleseed Center for Law and Economic Justice found that tying 5 the minimum wage to cost of living increases prevents wage 6 7 stagnation by ensuring that the minimum wage keeps pace with inflation. The report asserts that doing so would ensure that 8 9 the minimum wage would continue to grow as the cost of basic 10 necessities rises. Currently, thirteen states and the District 11 of Columbia index their minimum wage rates to the cost of 12 living, most often by linking their minimum wage rates to 13 consumer price data.

14 The purpose of this Act is to ensure financial security for 15 low wage workers in the State by linking Hawaii's minimum wage 16 increases to the consumer price index.

17 SECTION 2. Section 387-2, Hawaii Revised Statutes, is18 amended to read as follows:

19 "§387-2 Minimum wages. (a) Except as provided in section
