### A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that reliable
3	agricultural infrastructure that supports the State's land and
4	water resources is the lifeline of Hawaii's agriculture
5	industry. Increasing drought events, rain bombs, wildfires, and
6	other crises have highlighted the need for the timely repair and
7	maintenance of the State's agricultural infrastructure.
8	Sufficient funding is necessary to maintain and improve the
9	State's irrigation systems to ensure that Hawaii's crops receive
10	a steady and dependable supply of water. Additionally, funding
11	to develop the infrastructure of agricultural lands would
12	provide not only access and other support for local producers to
13	become financially viable, but also new and innovative
14	opportunities to grow the agriculture industry in the State.
15	Accordingly, the purpose of this part is to appropriate
16	funds for capital improvement projects for the agricultural
17	infrastructure of the State.

1 SECTION 3. The appropriations made for the capital 2 improvement projects authorized by this part shall not lapse at 3 the end of the fiscal year for which the appropriations are 4 made; provided that all moneys from the appropriations that are 5 unencumbered as of June 30, 2026, shall lapse as of that date. 6 PART II 7 SECTION 4. In accordance with section 9 of article VII of 8 the Hawaii State Constitution and sections 37-91 and 37-93, 9 Hawaii Revised Statutes, the legislature has determined that the 10 appropriations contained in Act 164, Regular Session of 2023, 11 and this part will cause the state general fund expenditure 12 ceiling for fiscal year 2024-2025 to be exceeded by 13 per cent. This current declaration takes 14 into account general fund appropriations authorized for fiscal 15 year 2024-2025 in Act 164, Regular Session of 2023, and this 16 part only. The reasons for exceeding the general fund 17 expenditure ceiling are that: 18 (1) The appropriation made in this part is necessary to 19 serve the public interest; and 20 The appropriation made in this part meets the needs (2)

addressed by this part.

1	SECTION 5. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$9,500,000 or so much
3	thereof as may be necessary for fiscal year 2024-2025 for the
4	establishment, operation, and administration of a food and
5	product innovation network.
6	The sum appropriated shall be expended by the agribusiness
7	development corporation for the purposes of this part.
8	SECTION 6. There is appropriated out of the general
9	revenues of the State of Hawaii the sum of \$4,411,426 or so much
10	thereof as may be necessary for fiscal year 2024-2025 for the
11	retirement of outstanding debt on the Waiahole water system.
12	The sum appropriated shall be expended by the agribusiness
13	development corporation for the purposes of this part.

15	SECTION 7. This Act shall take effect on July 1, 2024.
