# A BILL FOR AN ACT

RELATING TO THE EAST KAUAI IRRIGATION SYSTEM.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that the Hawaii State 2 Constitution mandates the State to conserve and protect 3 agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency, and assure the availability of 4 5 agriculturally suitable lands. 6 The legislature further finds that the Hawaii State Constitution establishes that: 7 All public natural resources are held in trust by the 8 (1)9 State for the benefit of the people; 10 The State has an obligation to protect, control, and (2) 11 regulate the use of Hawaii's water resources for the 12 benefit of its people; and 13 The State and its people further agree and declare (3) 14 that the spirit of the Hawaiian Homes Commission Act, 15 looking to the continuance of the Hawaiian homes 16 projects for the further rehabilitation of the 17 Hawaiian race, shall be faithfully carried out.

1	The legislature additionally finds that the Hawaii supreme
2	court has repeatedly provided guidance to the State on how to
3	fulfill its public trust duties regarding water. The supreme
4	court has ruled that the State is to apply a presumption in
5	favor of four public trust uses of water over other uses:
6	(1) The maintenance of waters in their natural state;
7	(2) Domestic water uses;
8	(3) Uses of water in the exercise of Native Hawaiian and
9	traditional and customary rights; and
10	(4) Uses by and reservations of water for the department
11	of Hawaiian home lands.
12	The legislature also finds that the east Kauai irrigation
13	system derives its water from the north and south forks of the
14	Wailua river as well as many smaller streams and that it is a
15	critical irrigation system that supports agricultural production
16	in Hawaii. The system currently services approximately 5,920
17	acres of agricultural lands on Kauai and is relied upon by
18	numerous farmers and ranchers. It is also a critical source of
19	water for land held by the department of Hawaiian home lands.
20	The department of Hawaiian home lands has a reservation from the
21	commission on water resource management of approximately five

1 hundred thousand gallons per day from the Wailua river for its
2 lands. The east Kauai irrigation system currently supplies
3 water to the existing users and has the potential to expand the
4 number of acres cultivated. Several improvements have been
5 identified that could add as much as three hundred acres of
6 farmland to the service area.

7 The legislature also finds that the east Kauai irrigation 8 system is a century-old system that requires repair, renovation, 9 and improvements. If lost, the cost to replace the infrastructure 10 would be exorbitant. No replacement system is reasonable, and if 11 the reservoir is decommissioned, 5,920 acres of agricultural land 12 will dry up.

13 The legislature also finds that the maintenance of the east 14 Kauai irrigation system and development of a plan to deliver water 15 to land held by the department of Hawaiian home lands are necessary 16 for the department to be able to use its reservation of water from 17 the Wailua river.

18 The purpose of this Act is to continue to provide 19 irrigation water to farm operations in east Kauai and support 20 the water system by:

1 (1)Appropriating funds to the agribusiness development 2 corporation for maintenance and improvements to the east Kauai irrigation system; and 3 4 (2) Establishing and funding positions to maintain and 5 improve the east Kauai irrigation system. 6 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 7 or so 8 much thereof as may be necessary for fiscal year 2024-2025 for 9 maintenance of and improvements to the east Kauai irrigation 10 system. 11 The sum appropriated shall be expended by the agribusiness 12 development corporation for the purposes of this Act. 13 SECTION 3. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2024-2025 to 16 establish and fund full-time equivalent ( FTE) 17 positions within the agribusiness development corporation to 18 maintain and improve the east Kauai irrigation system. 19 The sum appropriated shall be expended by the agribusiness 20 development corporation for the purposes of this Act.

1 SECTION 4. In accordance with section 9 of article VII of 2 the Hawaii State Constitution and sections 37-91 and 37-93, 3 Hawaii Revised Statutes, the legislature has determined that the 4 appropriations contained in H.B. No. , will cause the state 5 general fund expenditure ceiling for fiscal year 2024-2025 to be 6 exceeded by \$ per cent. In addition, the or 7 appropriations contained in this Act will cause the general fund 8 expenditure ceiling for fiscal year 2024-2025 to be further 9 exceeded by \$ or per cent. The combined total 10 amount of general fund appropriations contained in only these two Acts will cause the state general fund expenditure ceiling 11 for fiscal year 2024-2025 to be exceeded by 12 13 per cent. The reasons for exceeding the \$ or 14 general fund expenditure ceiling are that: 15 (1) The appropriations made in this Act are necessary to 16 serve the public interest; and 17 (2) The appropriations made in this Act meet the needs 18 addressed by this Act. SECTION 5. This Act shall take effect on July 1, 3000. 19
