### A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING UNIT CREATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 89, Hawaii Revised Statutes, is amended
- 2 by adding a new section to be appropriately designated and to
- 3 read as follows:
- 4 "\$89- Establishment of new bargaining units. (a) The
- 5 board shall adopt rules under chapter 91 establishing criteria
- 6 for the establishment of a new bargaining unit. The rules shall
- 7 include a requirement that any person proposing to establish a
- 8 new bargaining unit shall submit an application to the board
- 9 along with any relevant supporting documents.
- 10 (b) Upon approval of an application by the board, the
- 11 board shall submit a report to the legislature indicating that
- 12 the board has approved the application and shall include
- 13 proposed legislation effectuating the recommendation contained
- 14 in the report.
- 15 (c) If the board denies an application, the board shall
- 16 inform the applicant in writing of the reasons for the denial.
- 17 Upon correcting or satisfying the reasons for the board's

- 2 providing all steps taken to cure the reasons for the denial and
- 3 resubmit the application to the board.
- 4 (d) If the board denies an application and the applicant
- 5 determines that the application cannot be amended to conform to
- 6 the reasons for the denial and upon request by the applicant,
- 7 the board shall submit a report to the legislature documenting
- 8 the submission, documenting the denial of the application, and
- 9 setting forth the reasons for the denial; provided that no
- 10 report to the legislature shall be required under this
- 11 subsection if the board has submitted a similar report for a
- 12 similar new bargaining unit to the legislature within the
- immediately preceding five year period."
- 14 SECTION 2. This Act does not affect rights and duties that
- 15 matured, penalties that were incurred, and proceedings that were
- 16 begun before its effective date.
- 17 SECTION 3. New statutory material is underscored.
- 18 SECTION 4. This Act shall take effect upon its approval.
